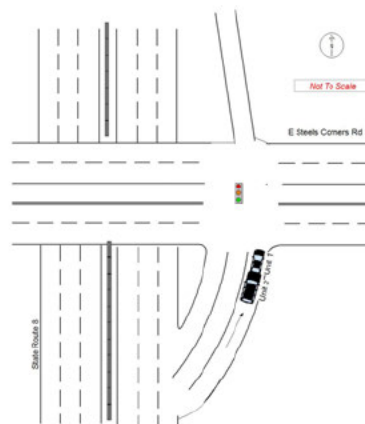
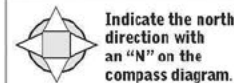

NARRATIVE

Unit #1 was stopped at the red light on the exit ramp from State Route 8 northbound at the intersection of E Steels Corners Road. Unit #2 was northbound directly behind Unit #1. Unit #2 failed to maintain an assured clear distance ahead, striking Unit #1 in the rear. Unit #2 would not return phone calls, and never provided a statement.

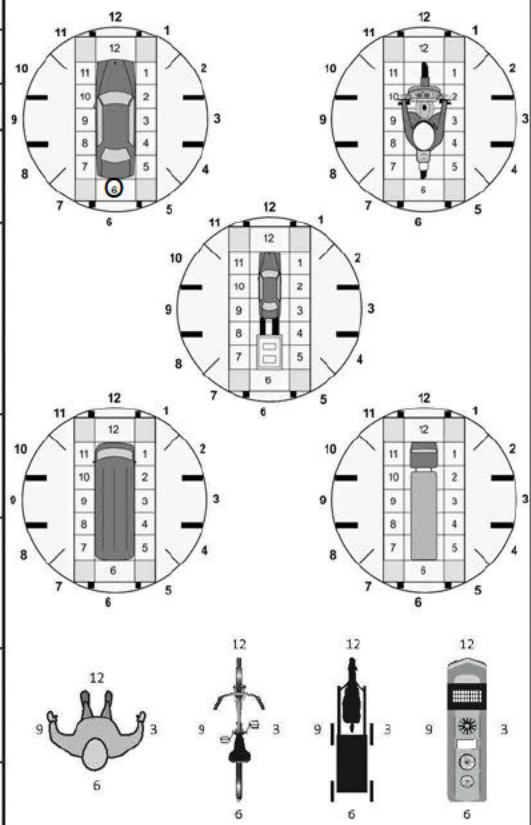
