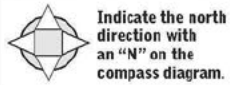

NARRATIVE Unit #1 was westbound on Wexford Blvd. Unit #1 struck the right side curb, the mailbox at 2879 Wexford Blvd., and another curb. Unit #1 continued driving recklessly failing to control the vehicle. Unit #1 possibly struck other curbs on Wexford and/or Fishcreek Rd. At one point, unit #1 stopped to inspect the vehicle but then drove off with severe damage. Police located the vehicle. The driver was subsequently arrested for OVI. Urine results are pending.
