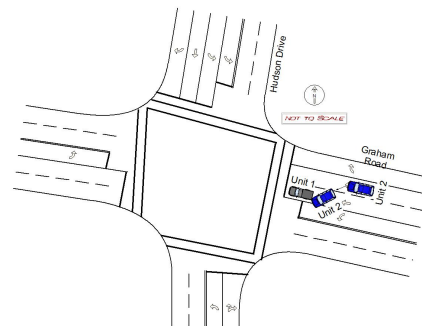
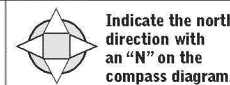

UNIT 1 WAS STOPPED AT A RED LIGHT IN THE LEFT THROUGH LANE, FACING WESTBOUND ON GRAHAM ROAD AT HUDSON DRIVE. UNIT 2 WAS TRAVELING WESTBOUND ON GRAHAM ROAD IN THE RIGHT THROUGH LANE. UNIT 2 ATTEMPTED TO CHANGE LANES, STRIKING UNIT 1. UNIT 2 THEN LEFT THE SCENE OF THE ACCIDENT.

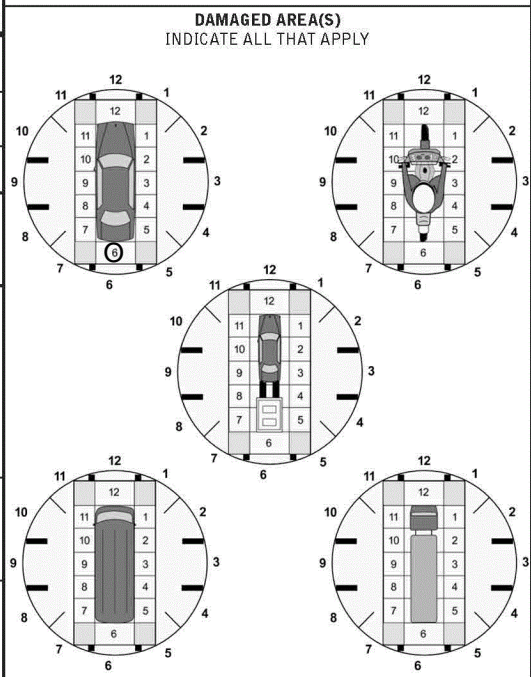
