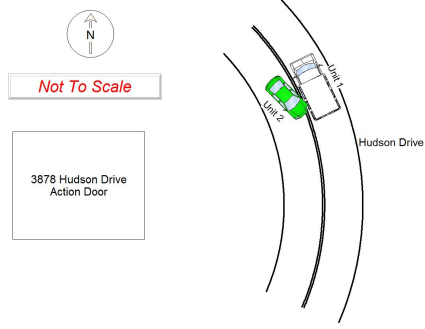

NARRATIVE
Unit 1 came into the Stow PD lobby on 4-17-23 to report a crash that occurred on 3-17-23. The driver of Unit 1, a passenger bus, stated he was n/b on Hudson Drive, in front of 3878 Hudson Drive (Action Door), when he was struck by a "lime green hatchback" which was s/b on Hudson Drive. Unit 1 stated he did not see the driver of the other car. Unit 1 stated he had one passenger in his bus at the time of the crash. At the time of this report, Unit 1 did not have any identifying information for the passenger, other than her name.

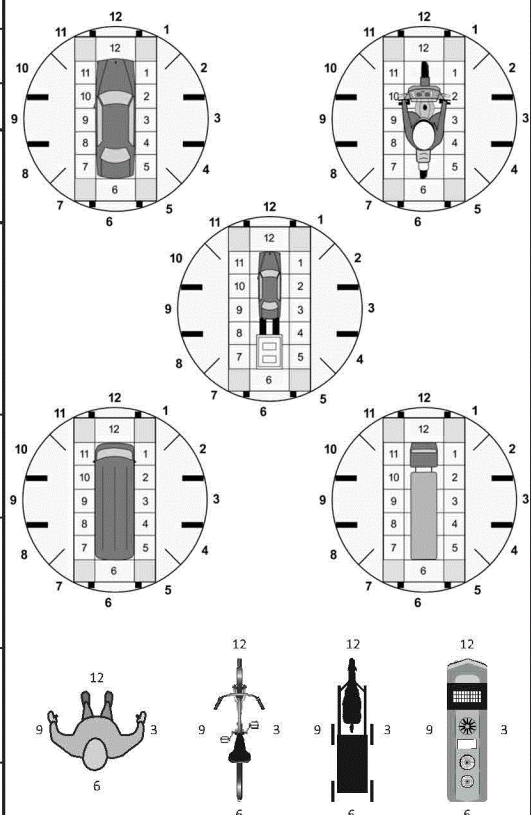

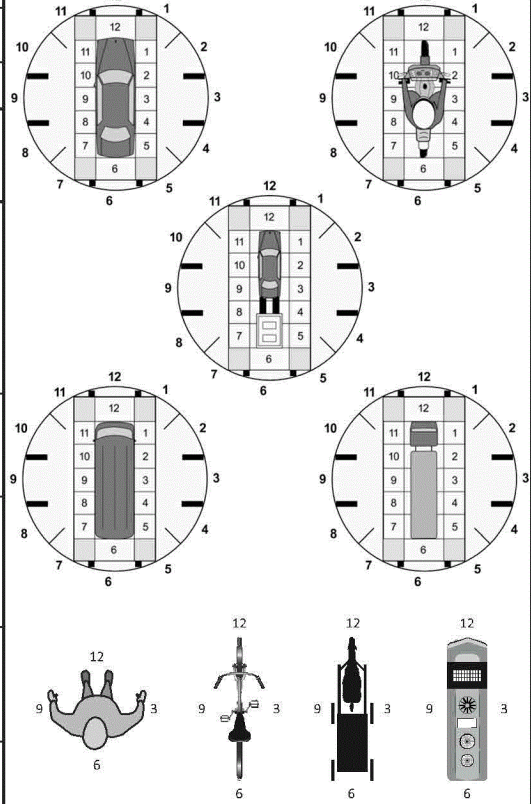
