NARRATIVE Unit 1 and 2 were both s/b on Darrow Rd. near 3773. Each Unit gave a different version of events leading up to the crash. I was unable to determine the at fault driver. Unit 1 reports while they were s/b in the left turn lane, Unit 2 was also s/b in the far right lane, but then abruptly pulled in front of them into the left turn lane. Unit 1 reports they had to swerve to the right to avoid them, but ultimately struck their rear bumper. Unit 2 reports they were s/b in the left turn lane when they were all of a sudden struck from behind by Unit 1.

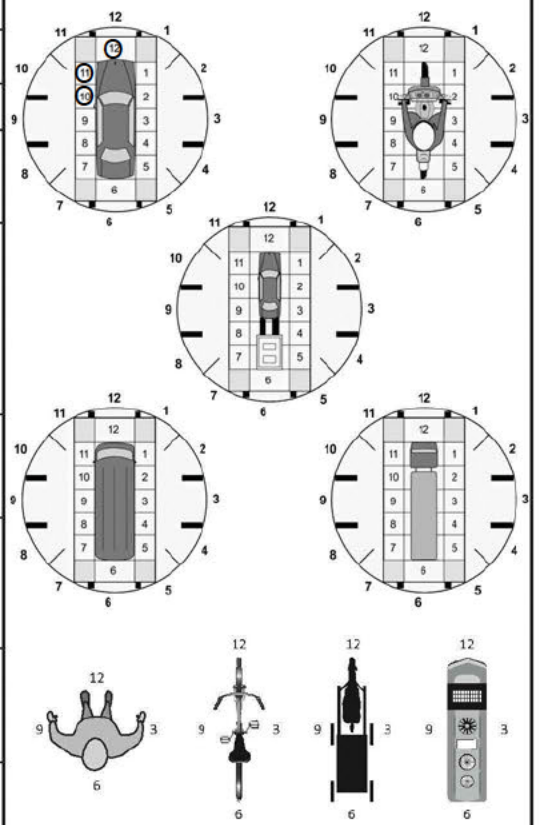

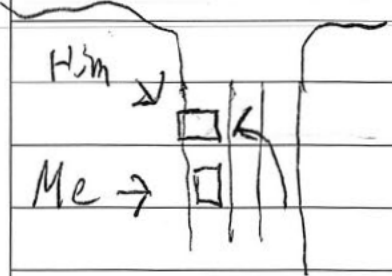
