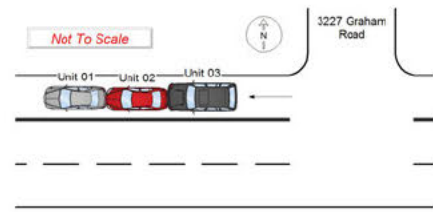
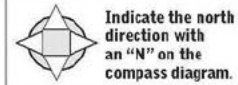

Unit 01 was traveling westbound in the 3200 block of Graham Road, stopped in traffic. Unit 02 was traveling directly behind Unit 01, also stopped in traffic. Unit 03 was traveling westbound behind Unit 02. Unit 03 failed to maintain assured clear distance ahead and struck Unit 02. This initial impact caused Unit 02 to strike Unit 01.

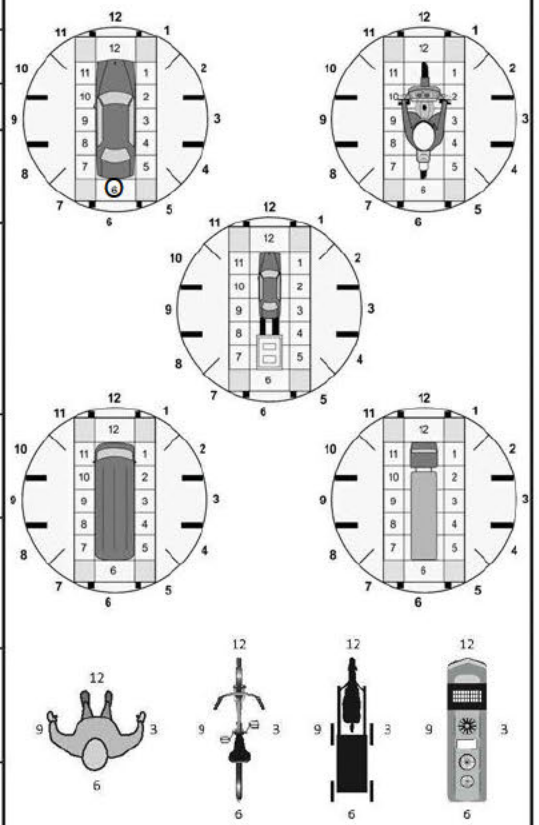

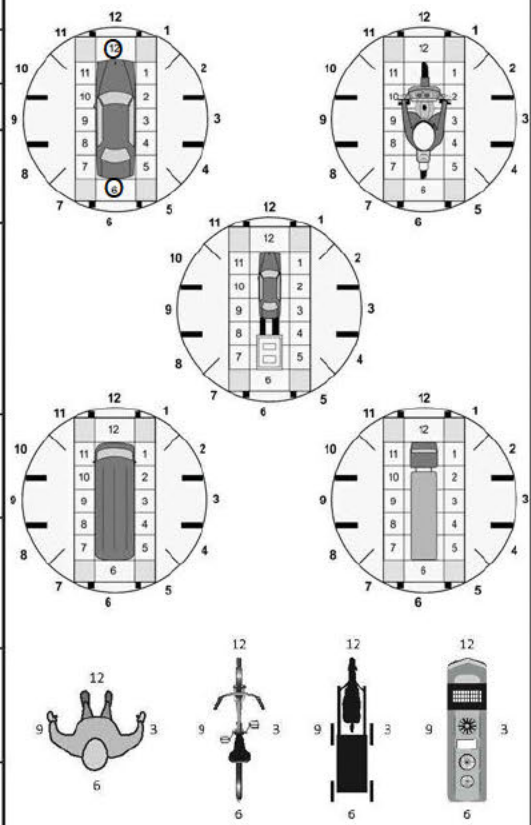

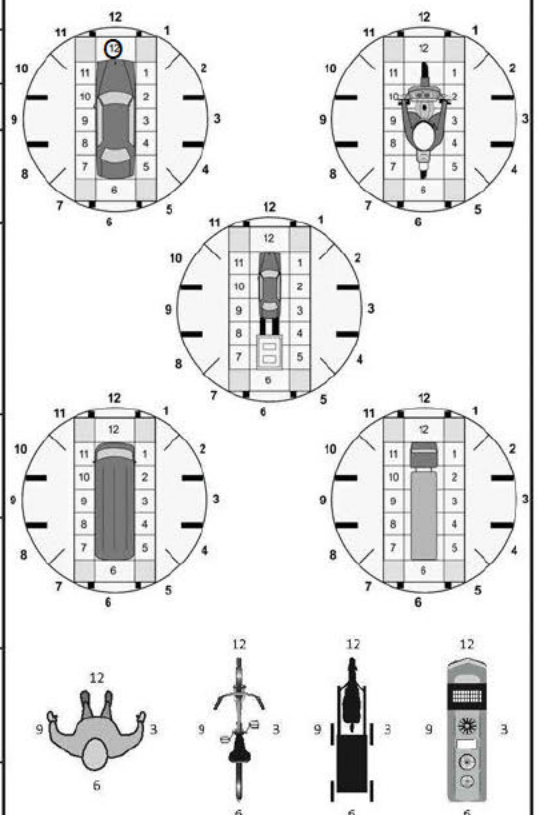
