 Unit #2 improperly backed into Unit #1. Unit #2 then left the scene.

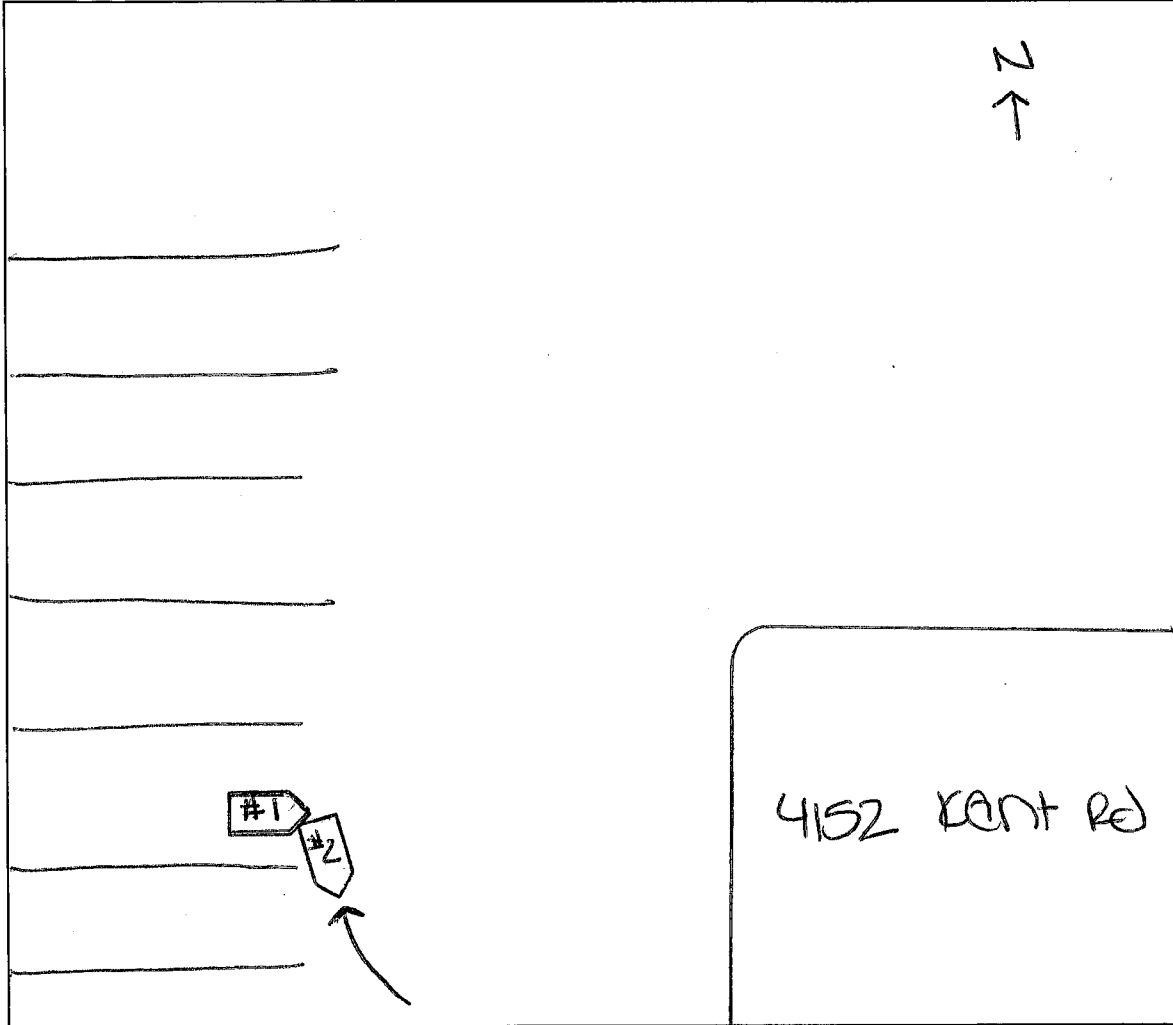
