Vehicle #1 was parked unoccupied in lot. When owner came out of business she observed that an unknown vehicle had struck Vehicle #1 and left.

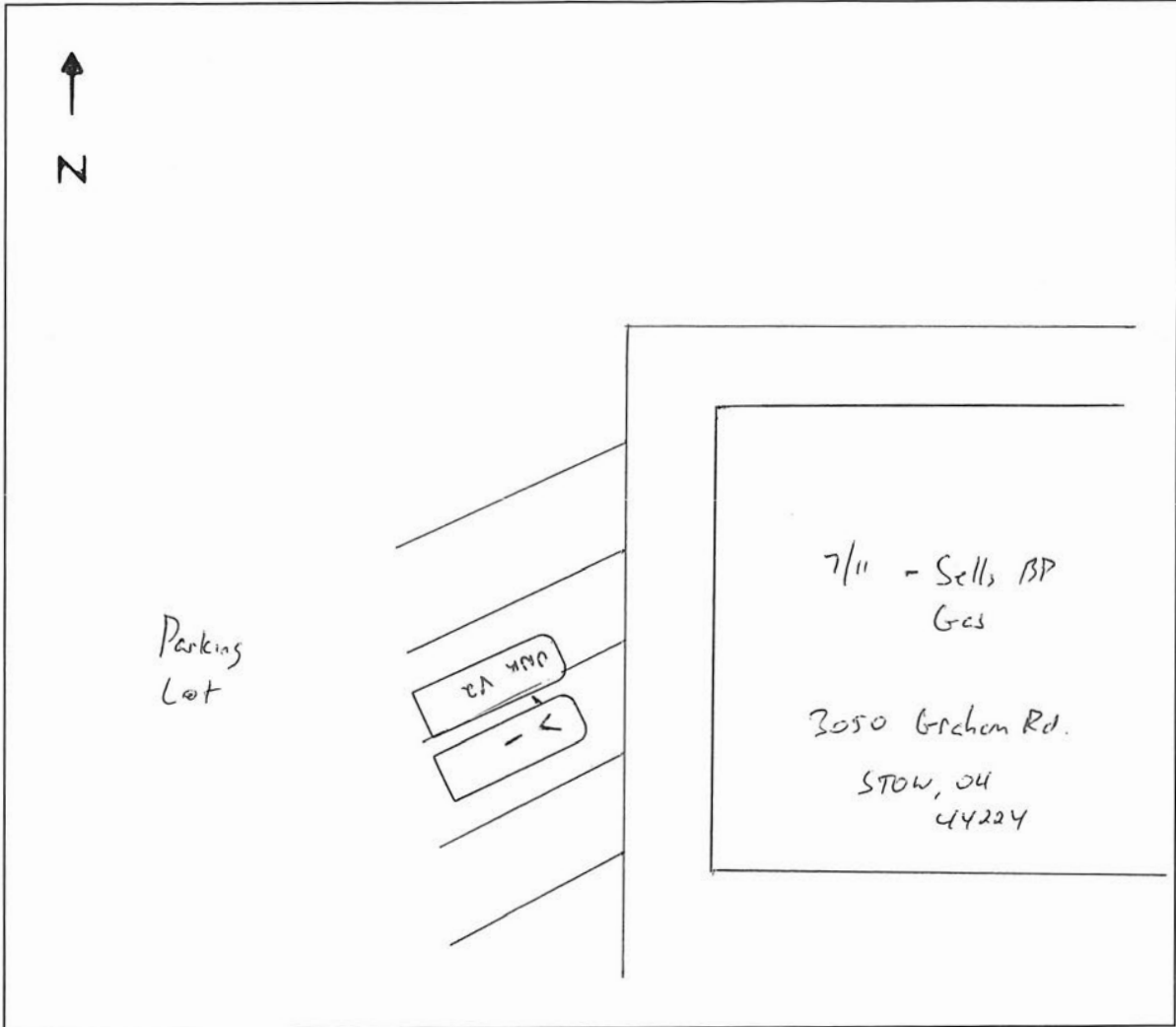
