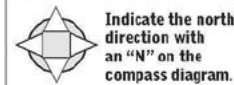
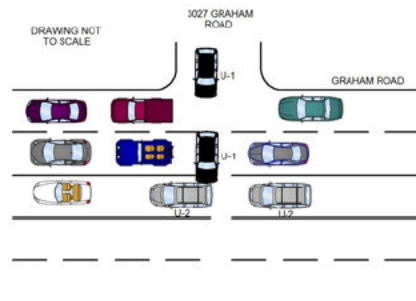

NARRATIVE

Unit-2 was in the left turn lane west-bound on Graham Road toward Fishcreek Road. Unit-1 was exiting the parking lot of 3027 Graham Road onto Graham Road to turn left/east. Traffic was backed up from the intersection and a car stopped to let unit-1 exit. Unit-1 continued but failed to yield exiting private property assuring it was clear to continue and struck the rear of unit-2 while attempting to turn left onto Graham Road.

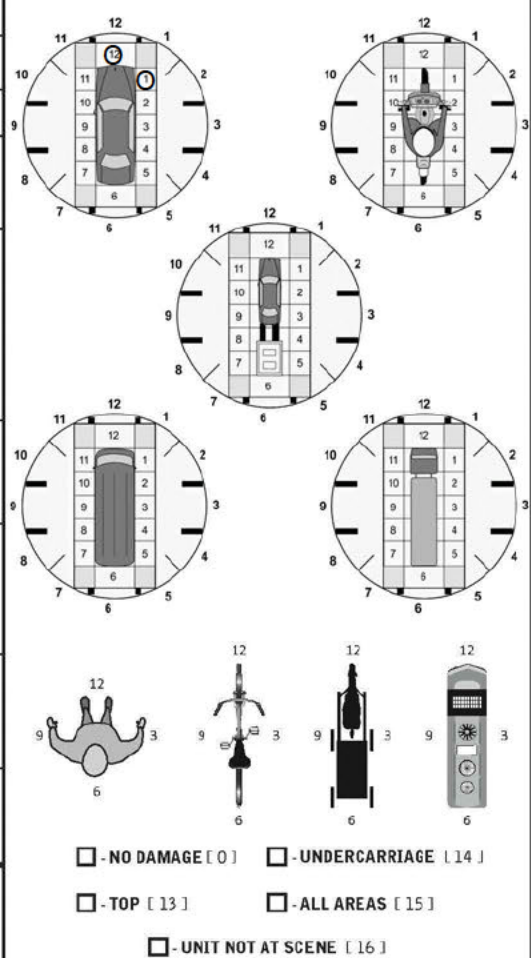

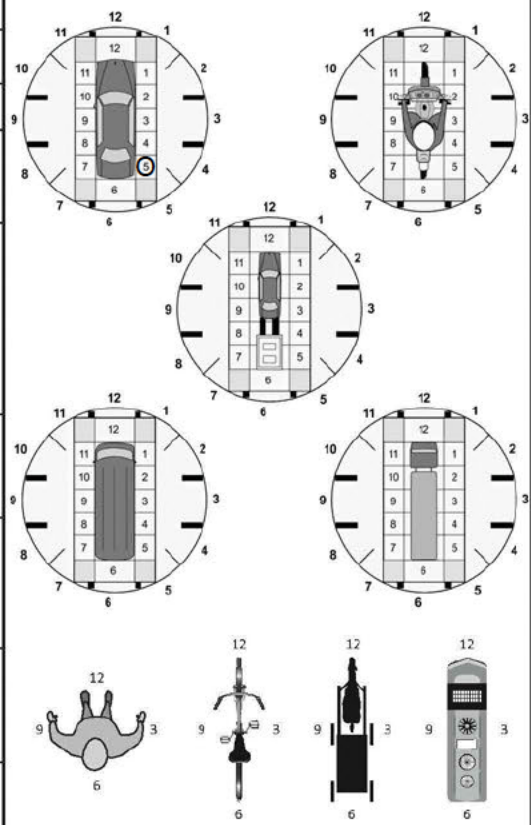
