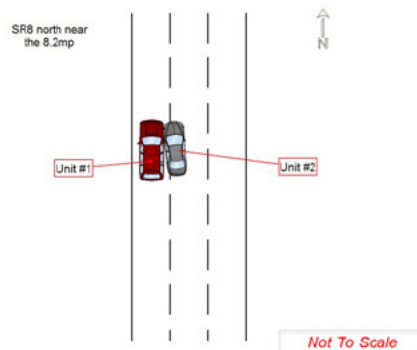

NARRATIVE

Unit #1 was northbound on SR8 in the left lane. Unit #2, either a gray Honda or Hyundai, was northbound on SR8 in the middle lane. Unit #2 began to switch into Unit #1's lane while failing to yield the right of way to Unit #1. The driver's side of Unit #2 struck the passenger side of Unit #1. Unit #2 then left the area without stopping and exchanging the proper information. It is estimated that this occurred near the 8.2 milepost.

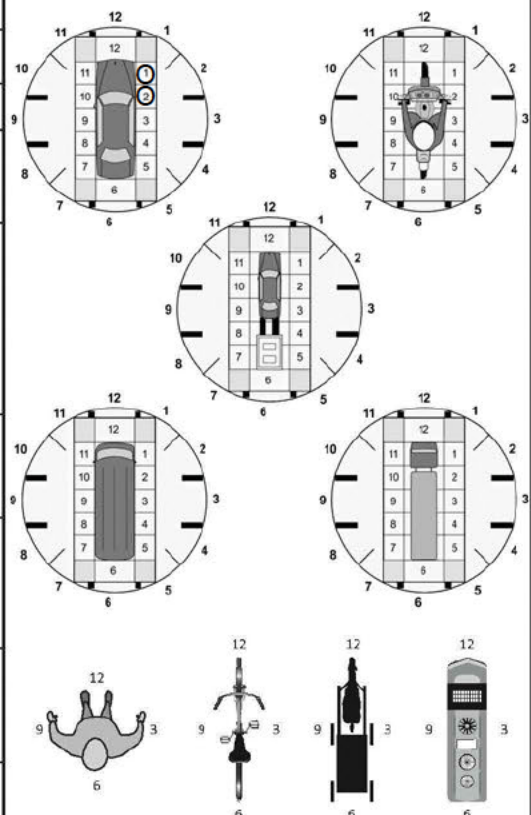
