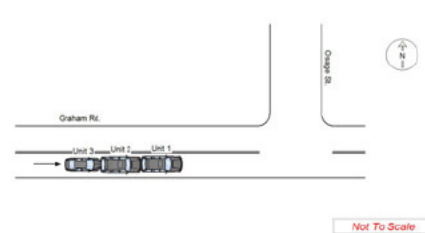
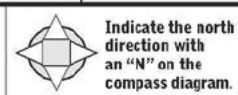

**Unit 1 was stopped in traffic while traveling east on Graham Rd. near Osage St. Unit 2 was stopped directly behind Unit 1. Unit 3 was traveling directly behind Unit 2 and failed to maintain an assured clear distance ahead, striking Unit 2 in the rear. This collision caused Unit 2 to strike Unit 1 in the rear. Unit 1 left the scene prior to officer arrival.**

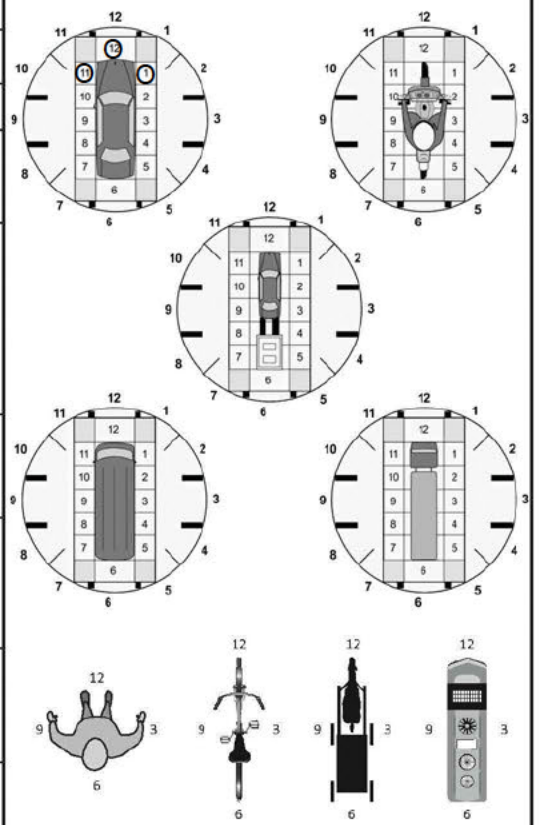
