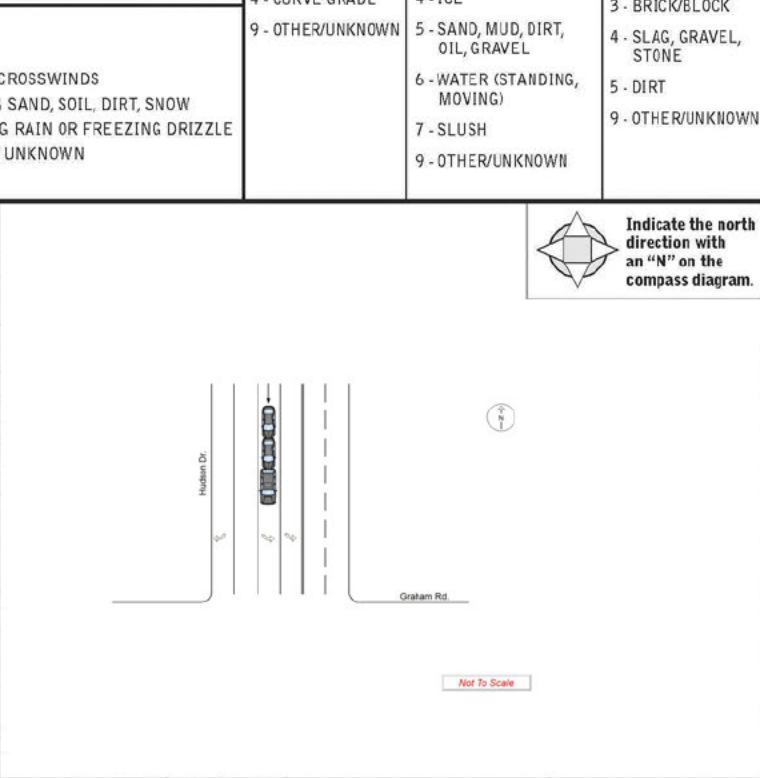

NARRATIVE

Unit 1 was stopped facing south at the traffic light on Hudson Dr. at Graham Rd. in the left turn lane. Unit 2 was slowed or stopped directly behind Unit 1. Unit 3 was traveling directly behind Unit 2 and failed to maintain an assured clear distance ahead, striking Unit 2 in the rear. The impact of Unit 3 striking Unit 2 caused Unit 2 to strike the rear of Unit 1.

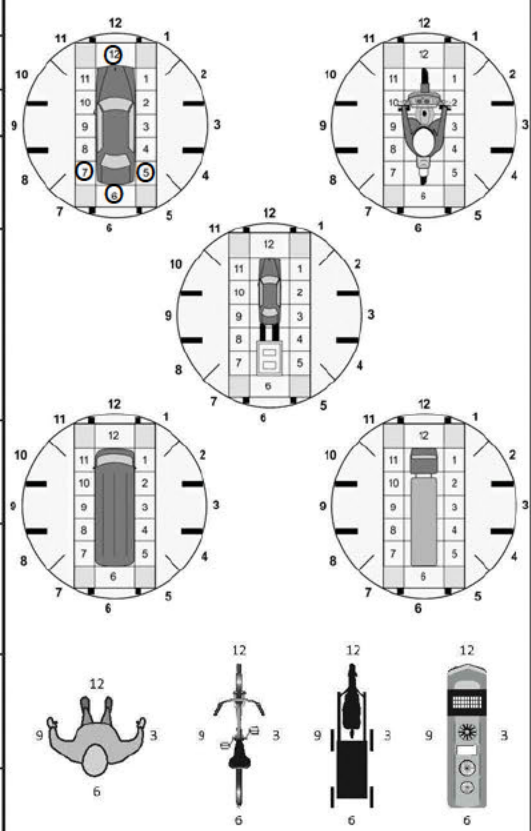

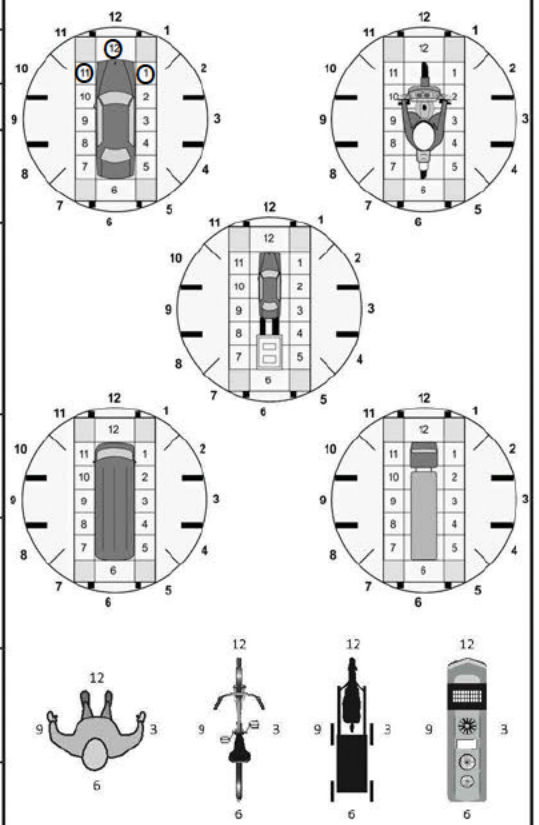
