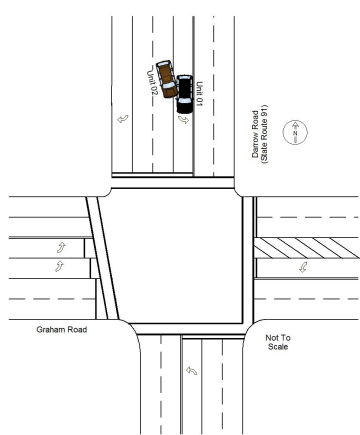

Unit 02 was also southbound on Darrow Road, approaching Graham Road, in the lane next to Unit 01. Unit 02 made an improper lane change and merged into Unit 01, striking them.

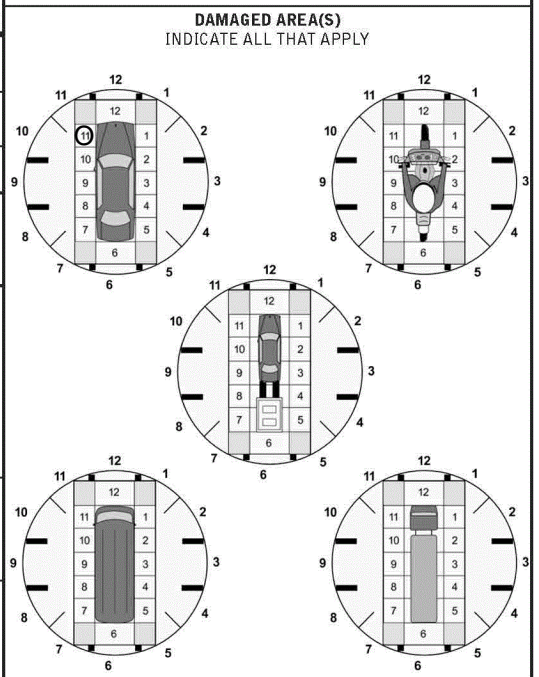

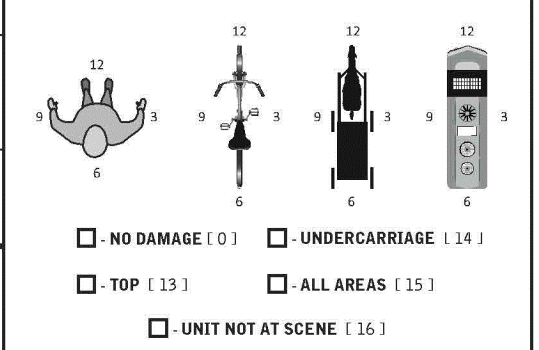
