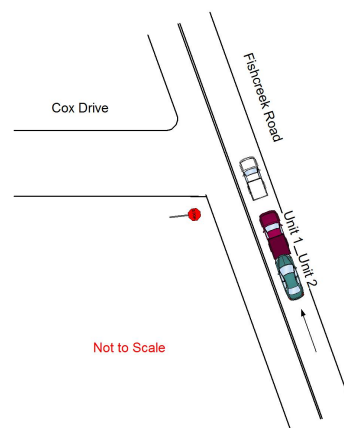
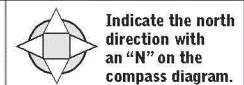

Unit #2 failed to maintain an assured clear distance ahead, striking Unit #1 in the rear. Both drivers declined to write an OH-3.**

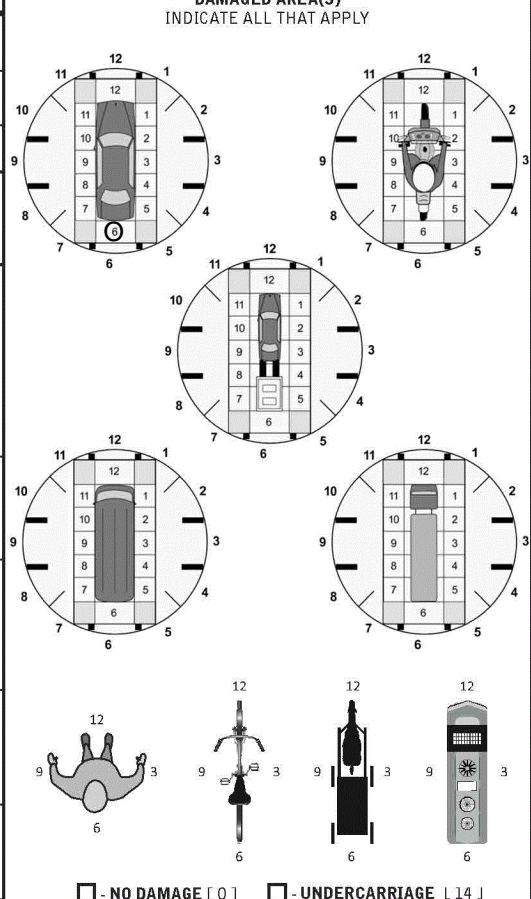

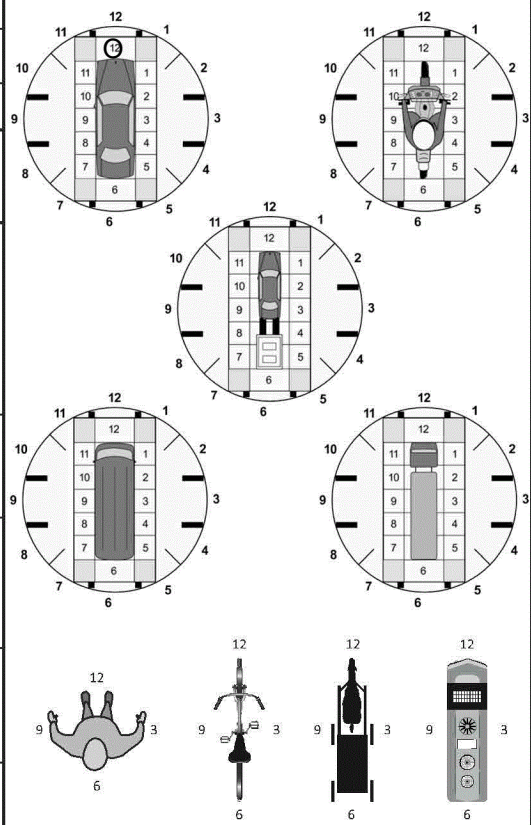
