UNIT #1 PULLED TO THE RIGHT OF UNIT #2. UNIT #2 STATED HE WAS WAITING ON TRAFFIC TO CLEAR TO TURN SOUTH ON HUDSON DR. UNIT #2 STATED HE HAD SEEN UNIT #1 BEHIND HIM. UNIT #2 STATED HE STARTED TO TURN ONTO HUDSON DR. UNIT #2 STATED HE LOOKED AT HIS TURN RADIUS TO THE RIGHT AND SAW UNIT #1 TO HIS RIGHT. UNIT #2'S TRAILER HIT THE DRIVER SIDE OF UNIT #1.

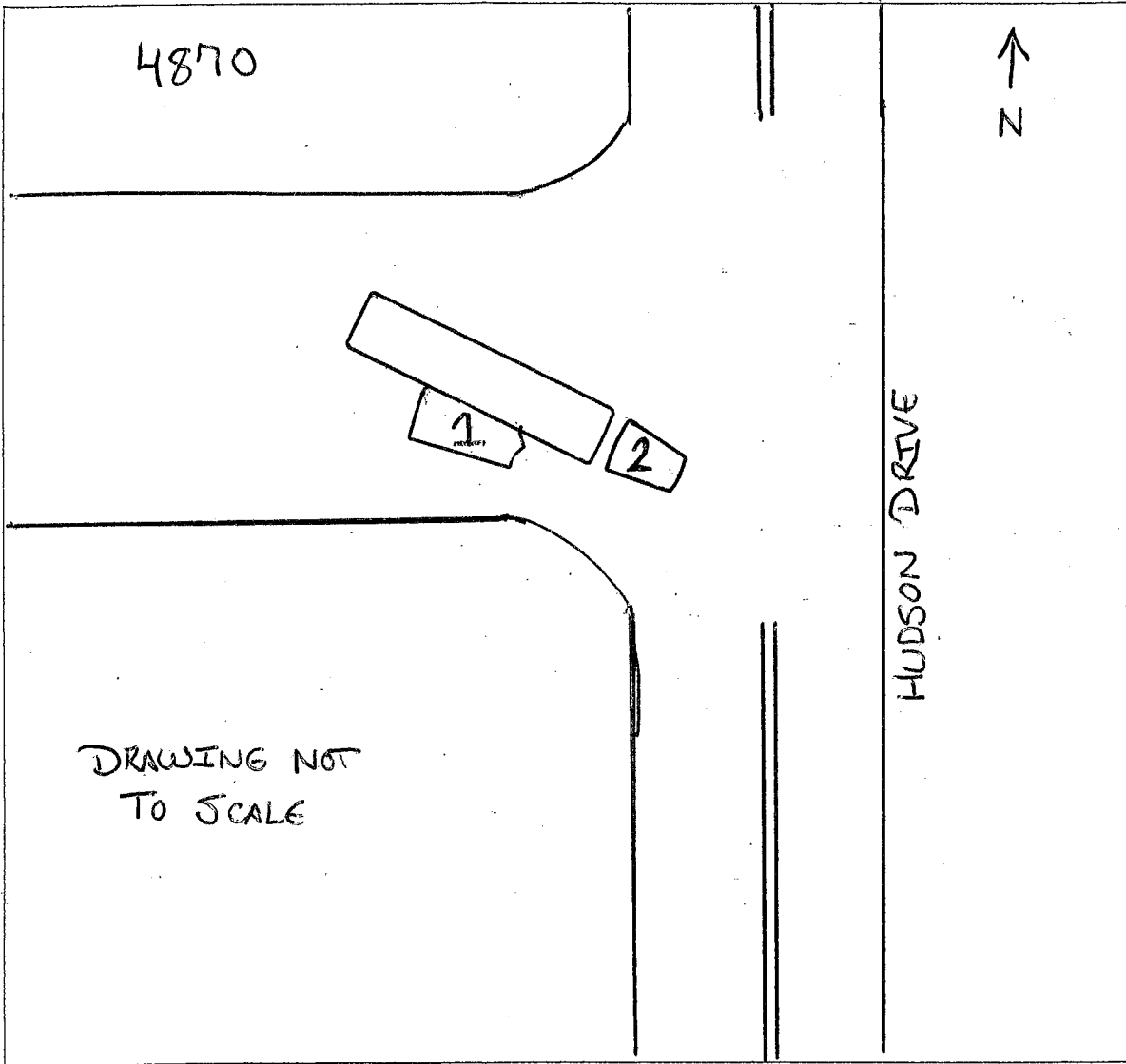
