**The owner of the fence, reported the accident on 07/02/23 @ 1451 hours.**

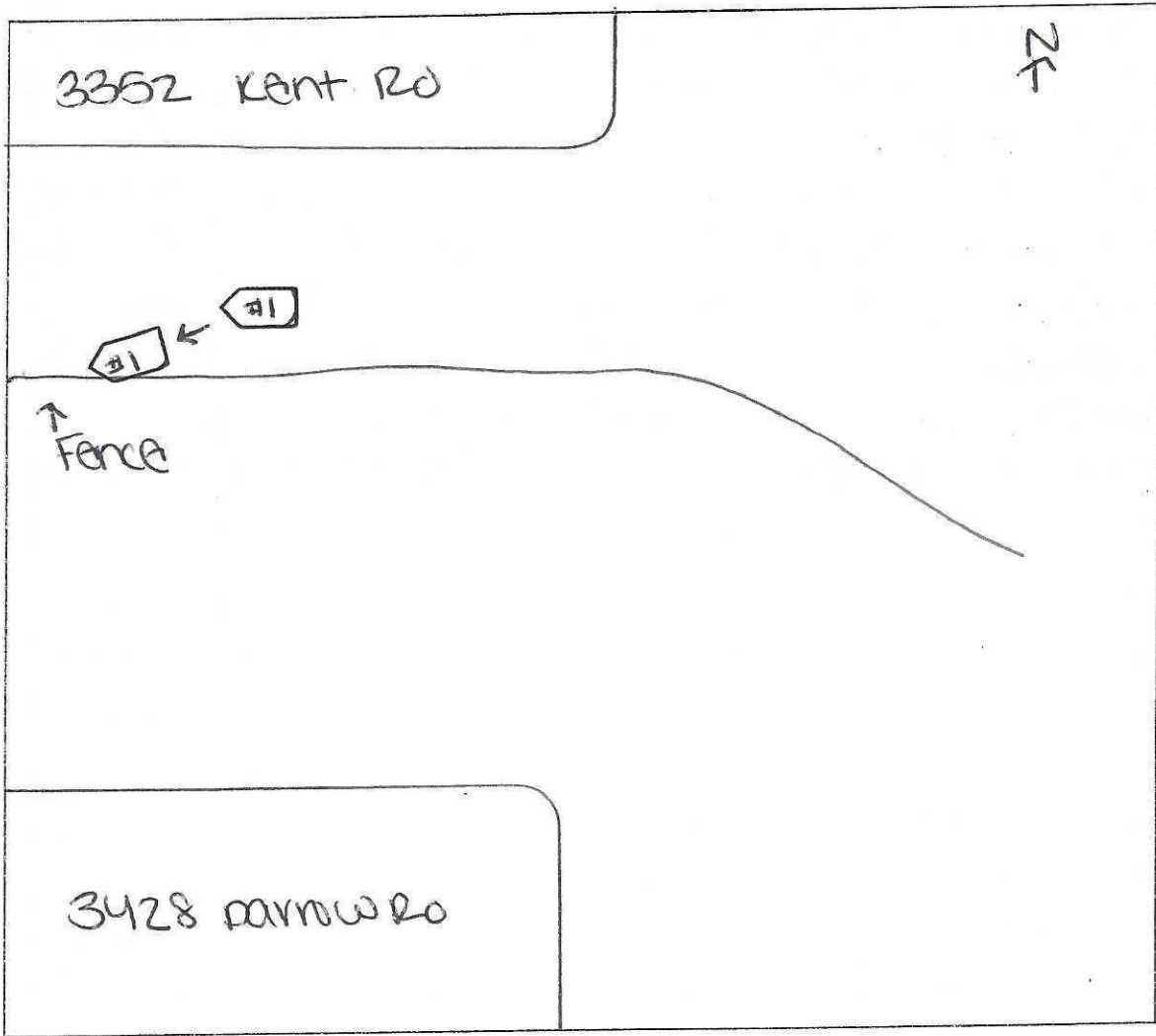
