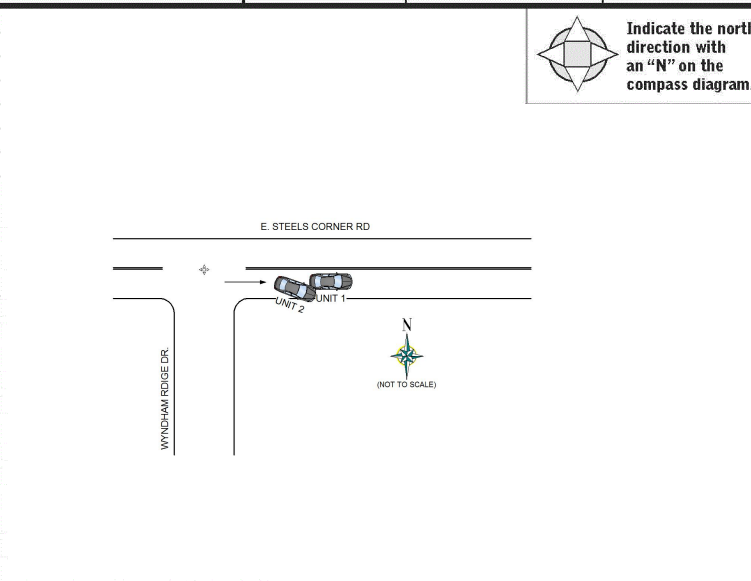

UNIT 1 WAS STOPPED IN TRAFFIC EB ON STEELS CORNERS JUST EAST OF WYNDHAM RIDGE. UNIT 2 FAILED TO MAINTAIN AN ASSURED CLEAR DISTANCE AND STRUCK THE REAR OF UNIT 1. UNIT 2 PROCEEDED TO REVERSE, THEN DRIVE AROUND THE VICTIM FLEEING THE SCENE. A WITNESS OBSERVED THE CRASH THEN FOLLOWED THE SUSPECT VEHICLE PROVIDING A LICENSE PLATE AND DIRECTION OF TRAVEL TO POLICE. AKRON POLICE DEPARTMENT LOCATED AND STOPPED
