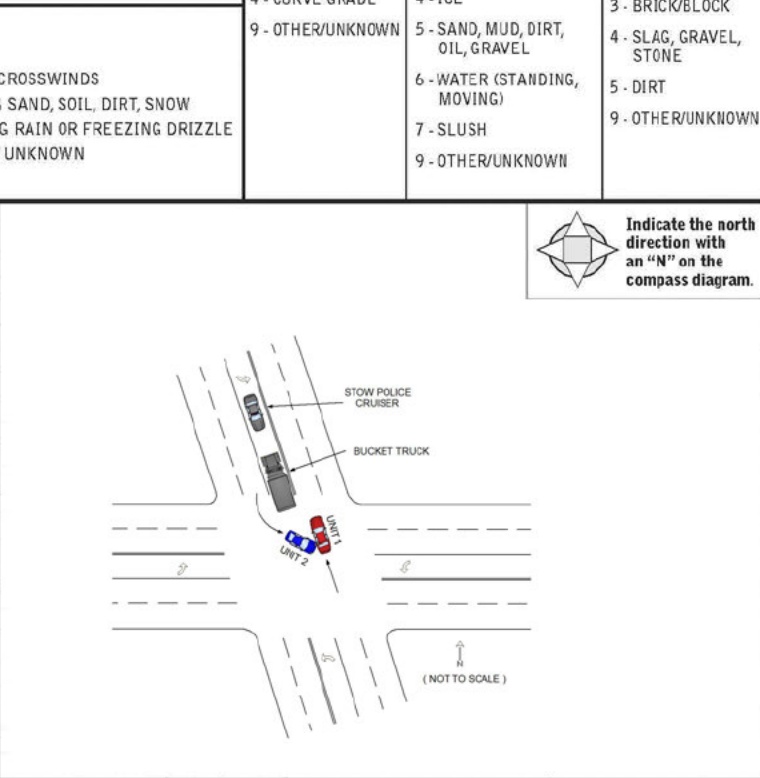

NARRATIVE

Unit 1 was Northbound on Fischcreek and Unit 2 was Southbound on Fishcreek. Unit 2 did not yield while making a left onto Graham Rd. and struck the side of Unit 1 while it was northbound. A larger commercial bucket truck and police cruiser were stationary in the Southbound left turn lane of Fishcreek Rd. doing work to the traffic signals when the crash occurred. Crash captured on Car 14 DashCam.

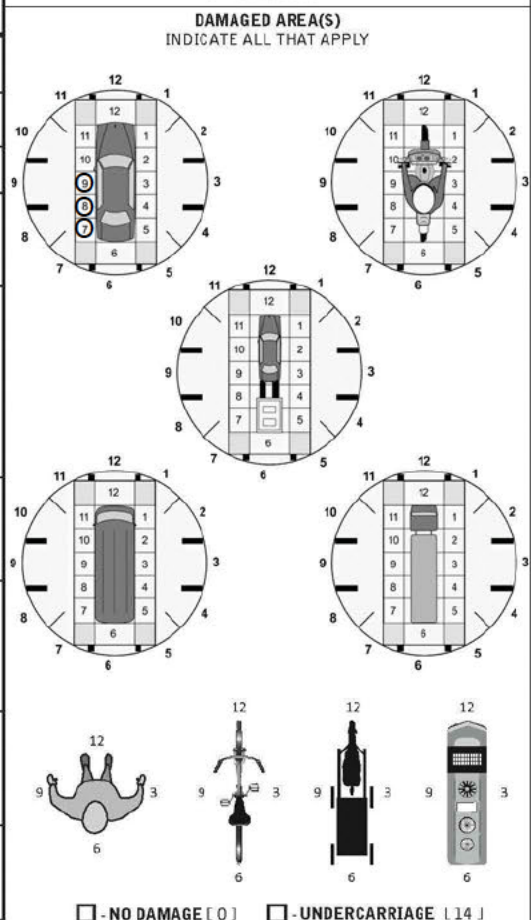
