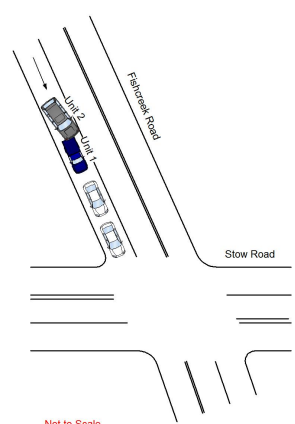

Unit #1 was southbound on Fishcreek Road. Unit #2 was directly behind Unit #1. Traffic in front of Unit #1 began to slow down as they approached the intersection at Stow Road. Unit #1 slowed down, but Unit #2 failed to maintain an assured clear distance ahead, striking Unit #1 in the rear. Both drivers declined to complete an OH-3.

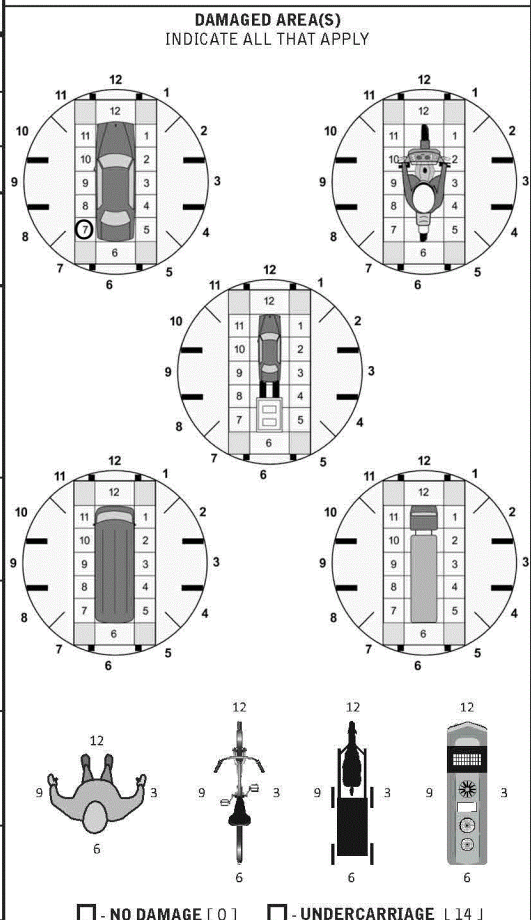

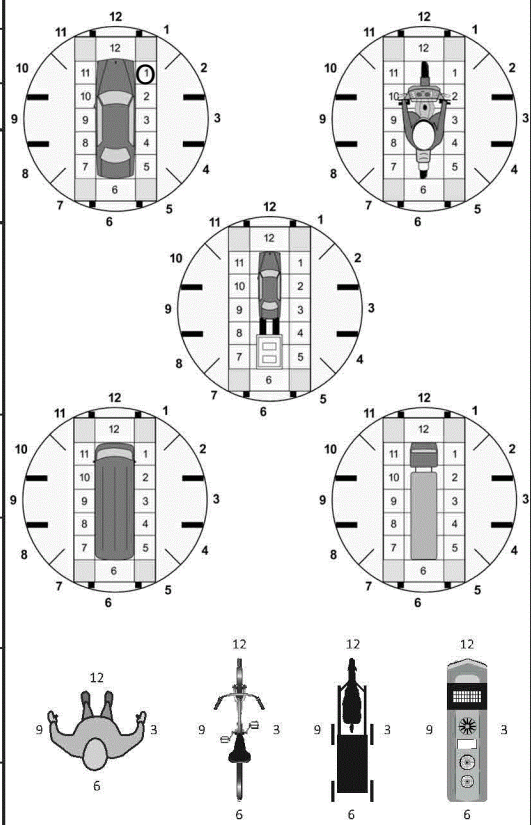
