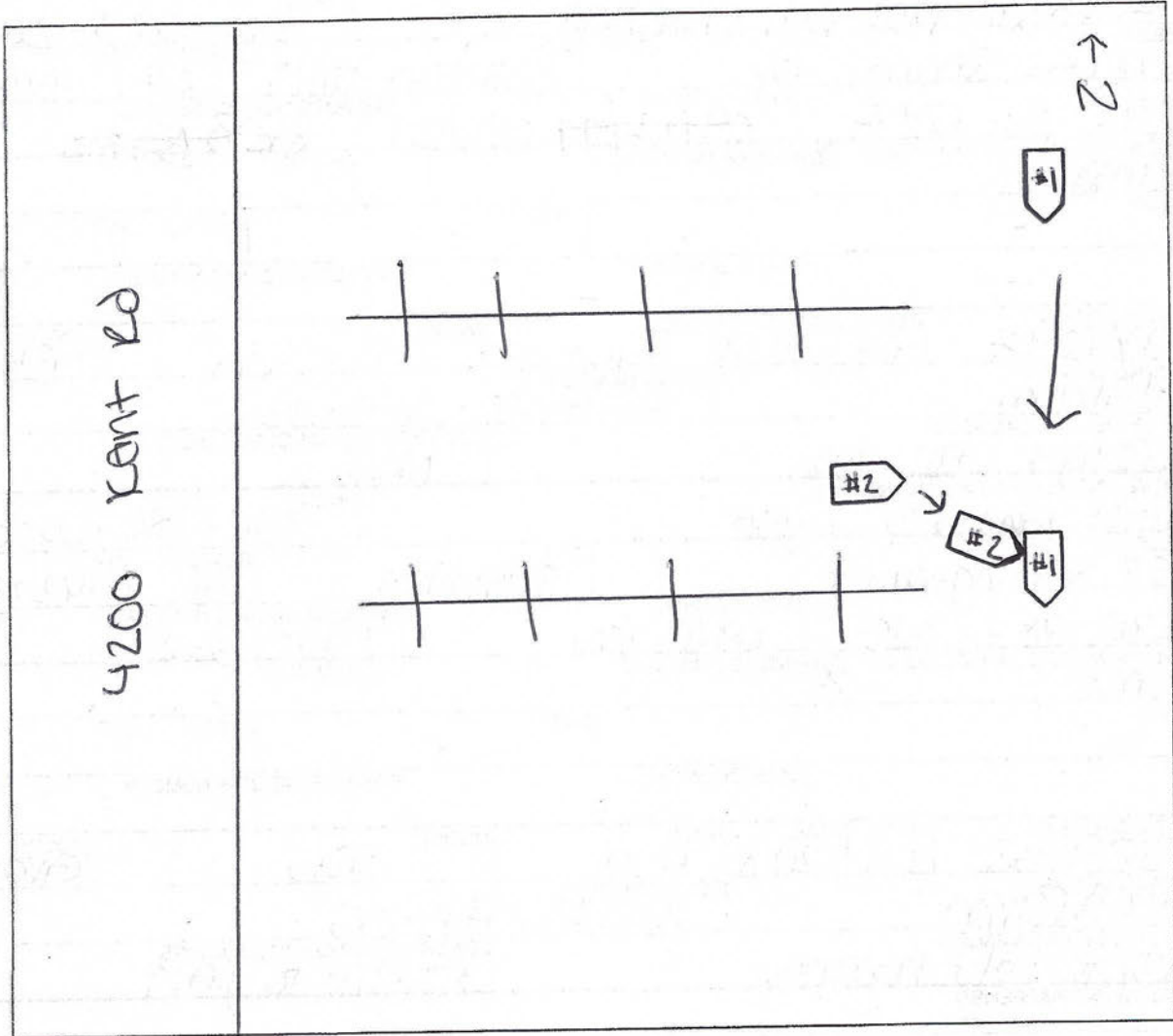

I was departing the parking lot turning right into the main aisle/road of the shopping center. I saw an oncoming car from the left that stopped and turned on their left turn signal to enter the parking lot about 100 feet away, so I assumed I was clear to turn right.
