DESCRIBE WHAT HAPPENED

Unit 01, a pedestrian, was seated on a bench near the parking lot. Unit 02 entered a parking space directly in front of where Unit 01 was seated. Unit 02 failed to maintain control and accelerated through the parking space, over the concrete parking block, and struck Unit 01. Unit 01 became pinned between the front of Unit 02's vehicle, the bench, and the side of the building. Unit 01 was seriously injured and transported to the hospital by EMS. 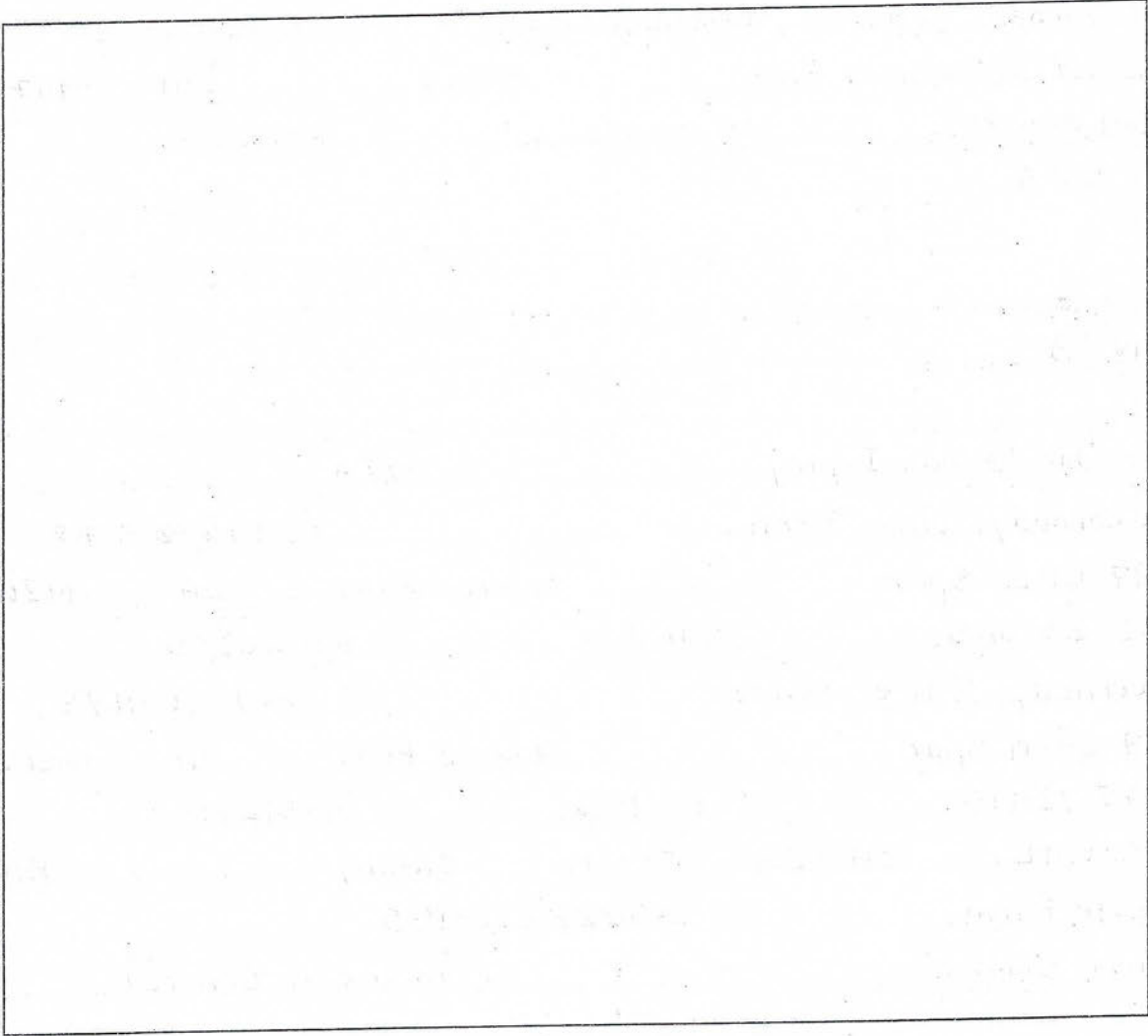

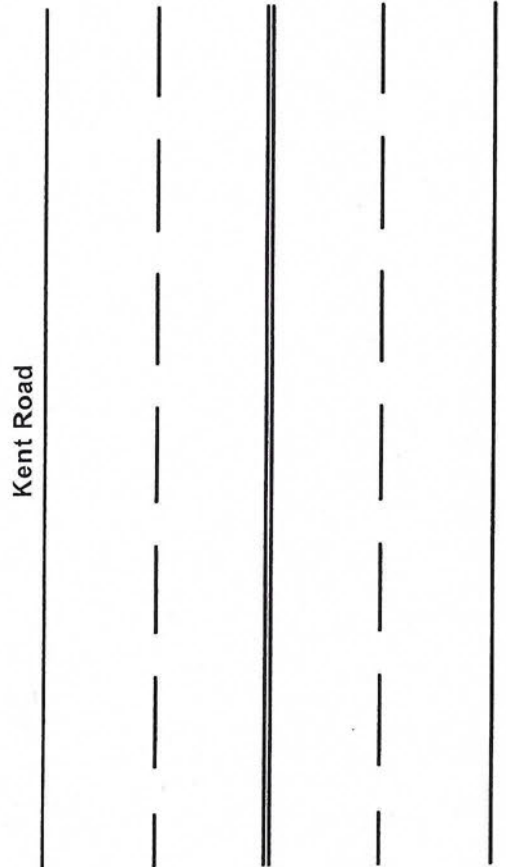
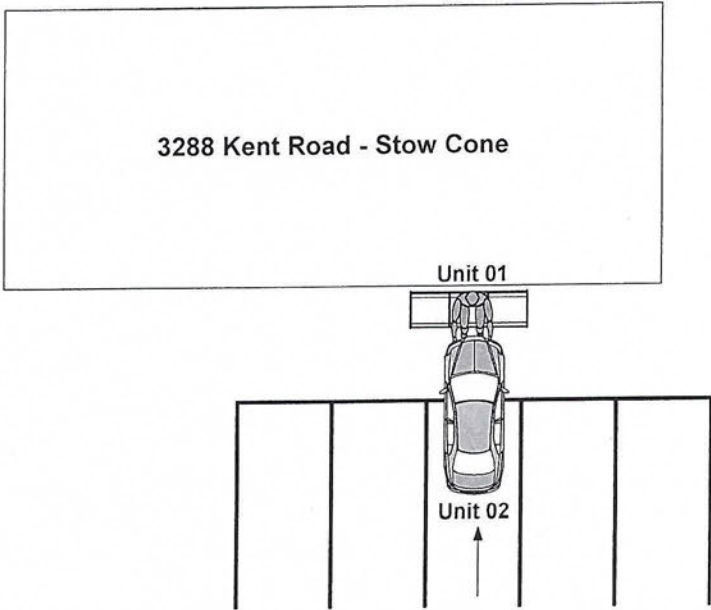
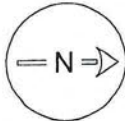
