
DESCRIBE WHAT HAPPENED

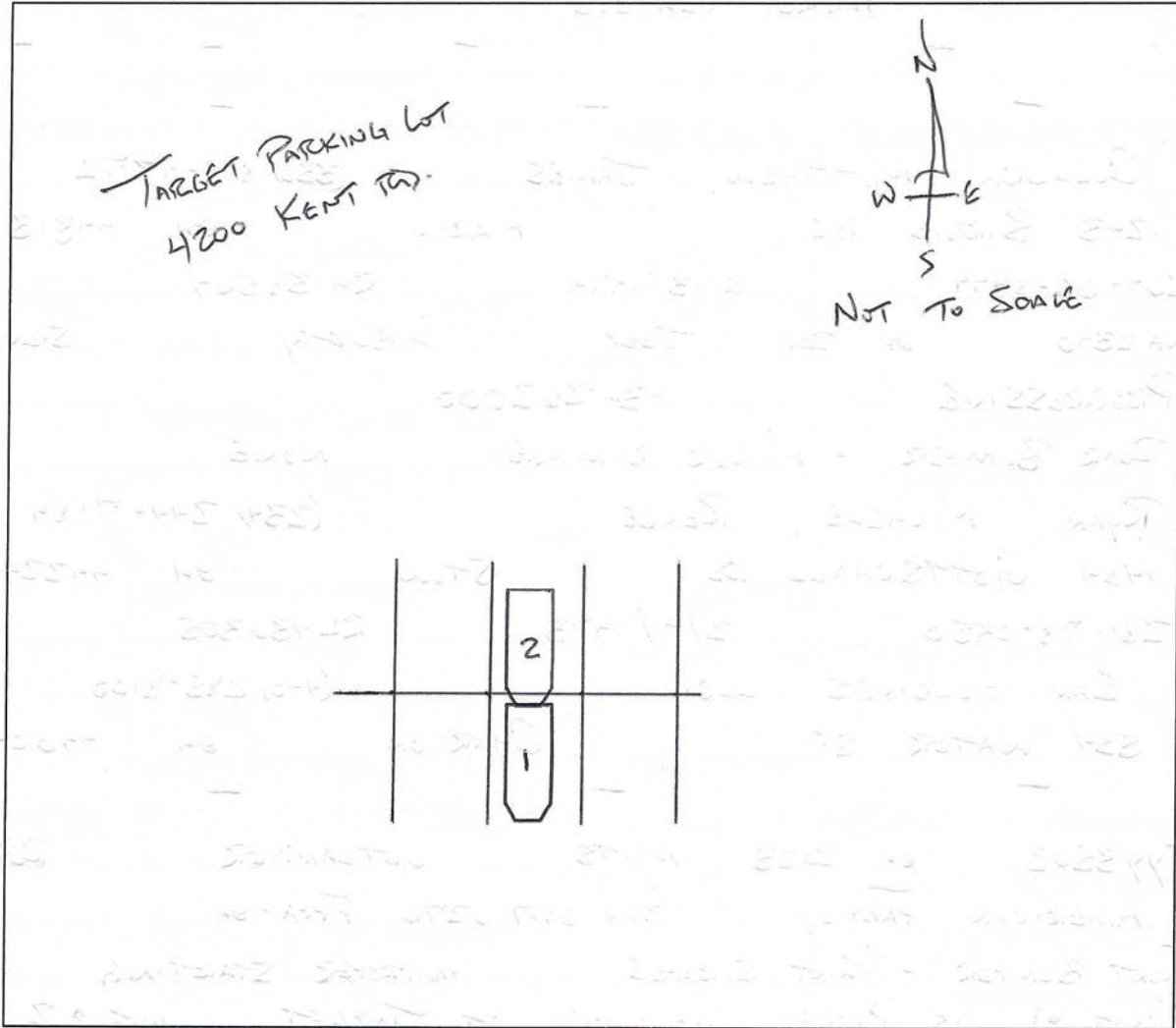
