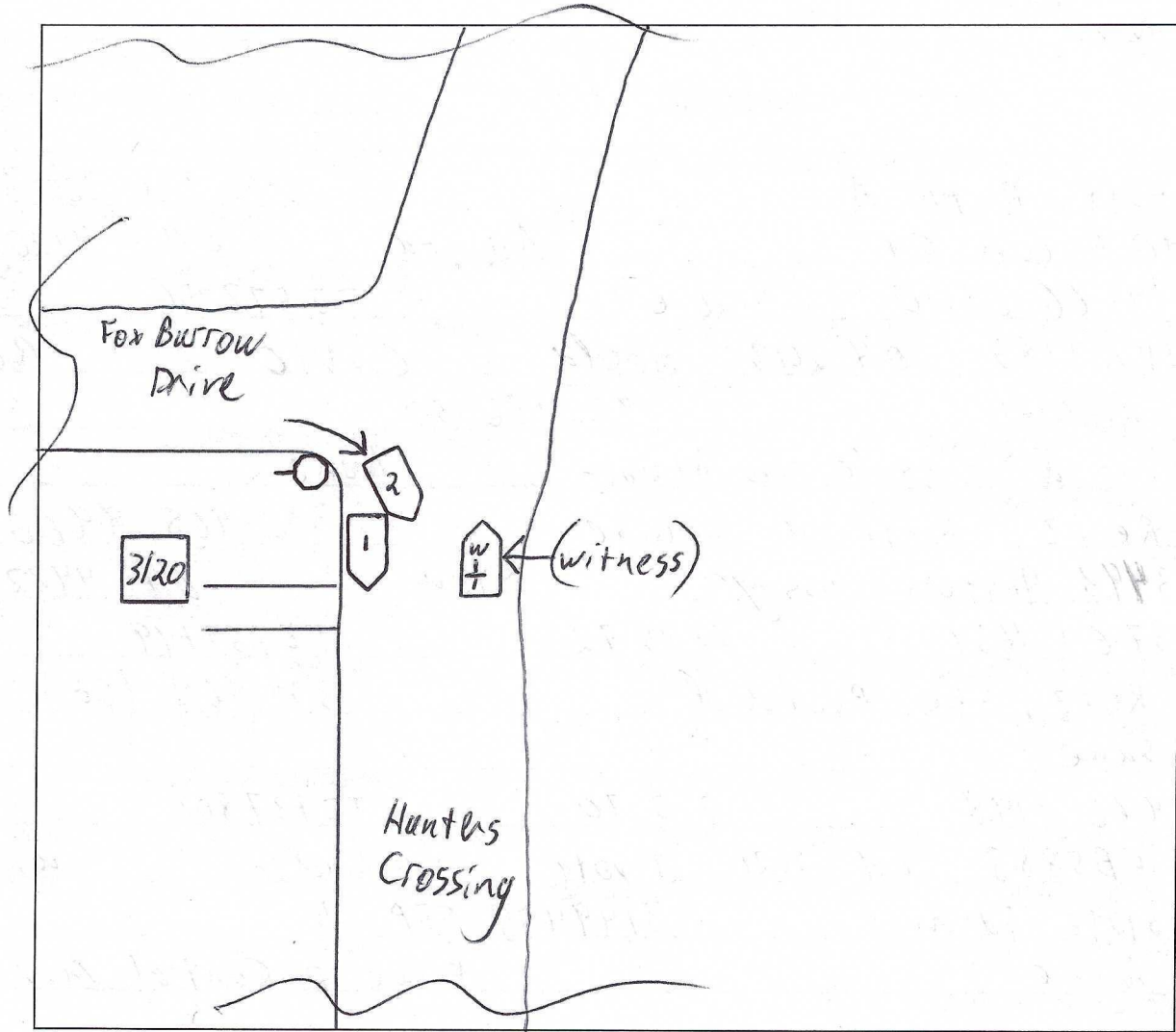

X On the evening of 9-20-23 at approximately 8:30pm I came into Hunter's Crossing development to the stop sign on Fox Burrow. I met a large gray truck facing me coming to my right where I was going to turn. The headlights were eye level and blinding my line of vision. There was a red car to the end of curb I could not see due to the blinding headlights. I went to turn right and my headlights shined on the red car. My car is programmed to slam on brakes when it is too close to something in the front view cameras. I felt the car jolt and brake, and I was close to the car but I never felt the 2 cars collide. There is no scratch or red paint on the side of my car where the hit may have happened. The girl with the red car came to my house and talked to me. I gave her my phone number for questions. Also, the girl in the gray truck said "Sorry my lights did that to you".
