NARRATIVE <p>All three units were north-bound on SR-8 just south of the Seasons Road exit. Unit-1 was leading unit-2 and unit-3 was behind unit-2. Unit-1 states that she attempted to switch to the middle lane but couldn't so she tapped her brakes and was hit by unit-2. Unit-2 and unit-3 both state unit-1 slammed on her brakes for no apparent reason causing unit-2 to hit unit-1 and unit-3 to side-swipe unit-2 while trying to go around unit-2. Unit-3's dashcam corroborates unit-2 and unit-3's statement. Unit-1 appears to have quickly slowed in traffic for no apparent reason causing the accident.</p>

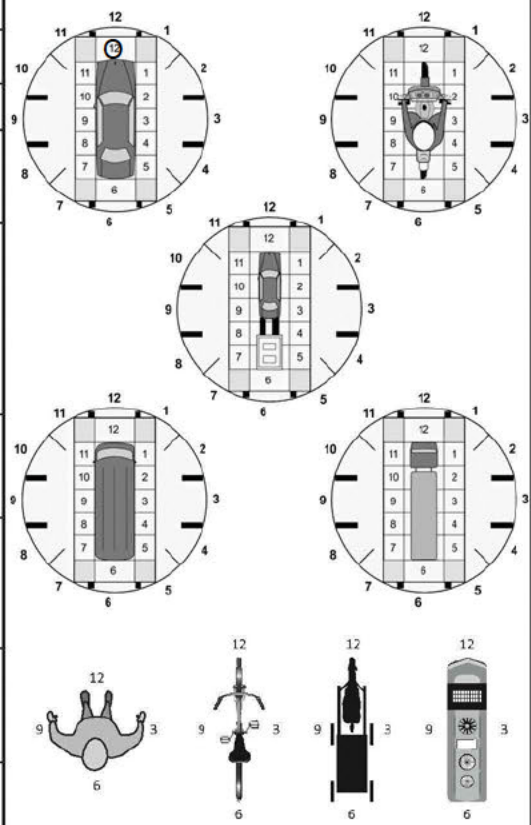

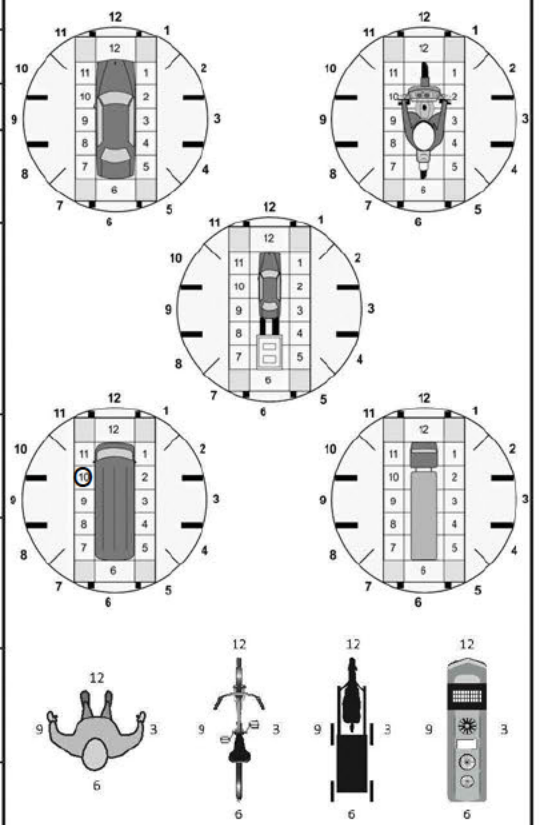
