UNIT ONE WAS STRUCK BY UNIT TWO AFTER UNIT TWO FAILED TO YIELD AND THE LANE ENDED. UNIT ONE ALSO SPED UP AND WOULD NOT ALLOW UNIT TWO OVER. CRASH RESULTED IN MINIMAL DAMAGE.

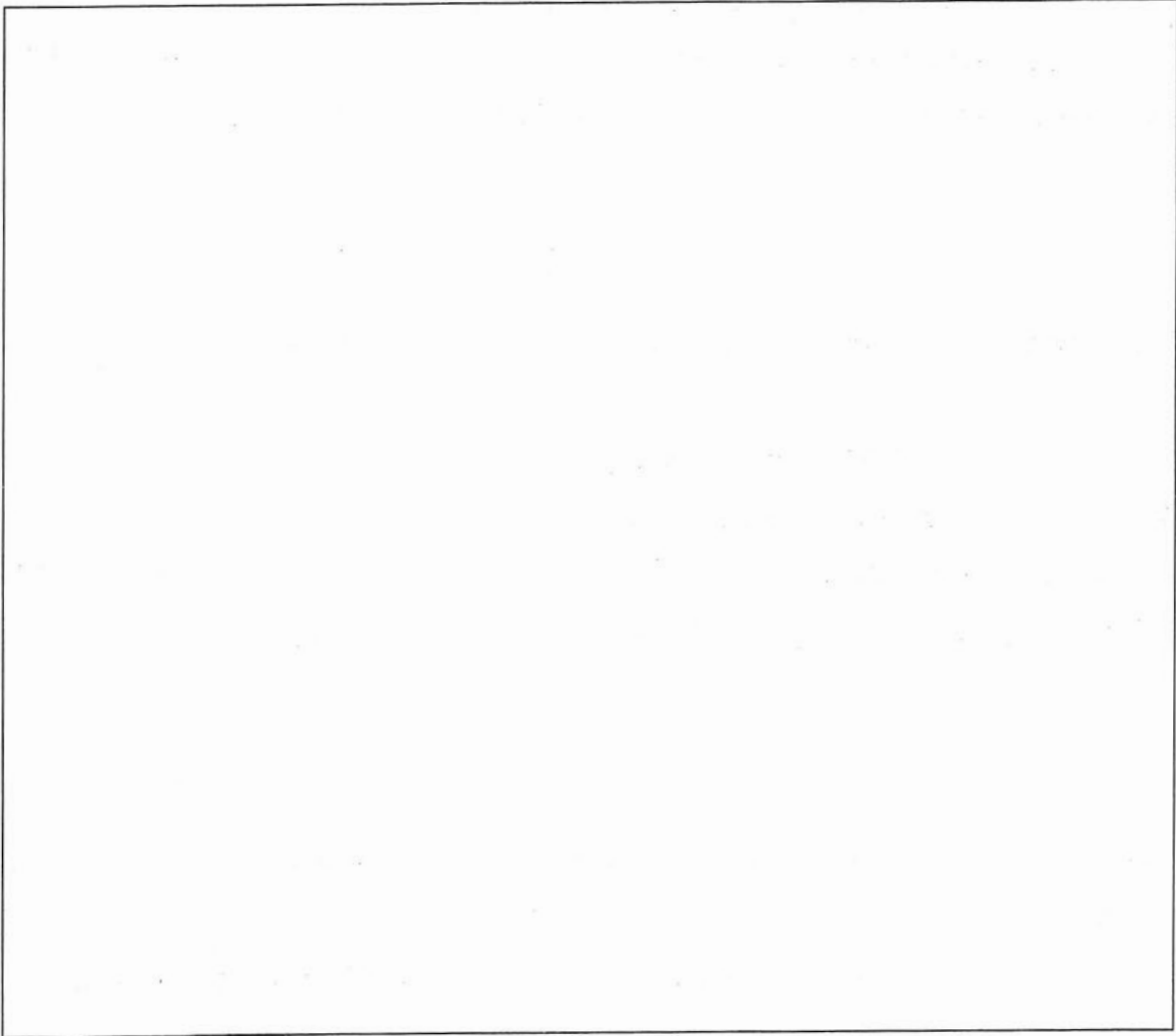

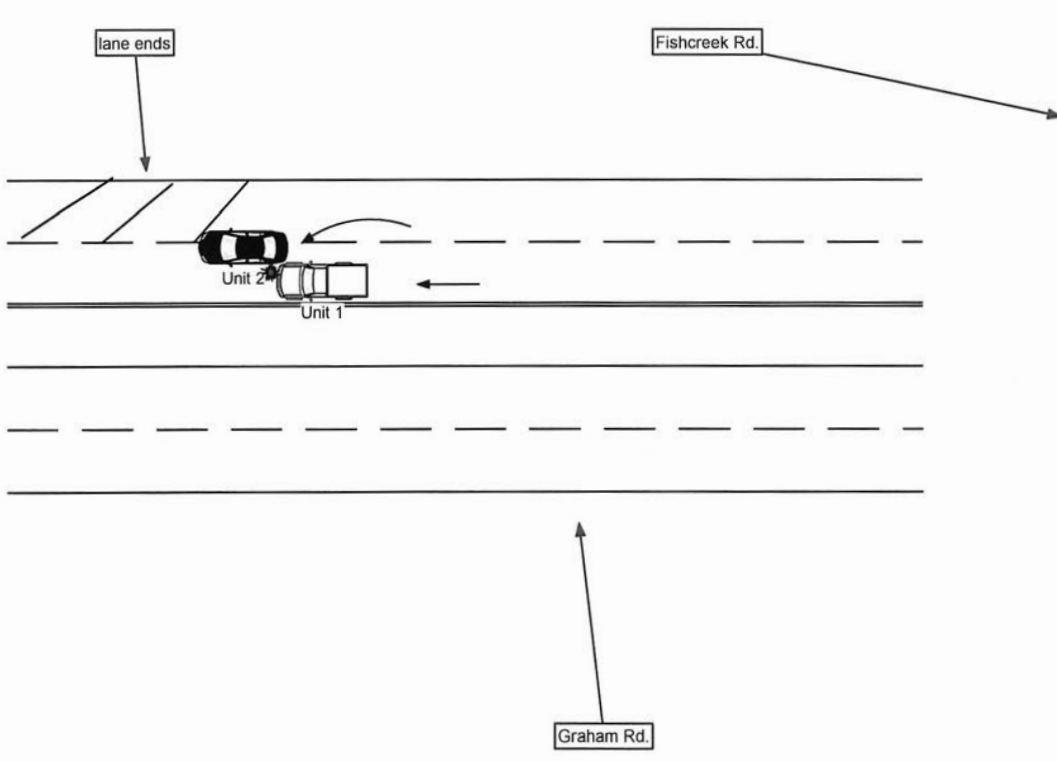

<p>I was merging with my blinker on from the right lane into the left lane, almost fully into the left lane when the pickup behind me laid on his horn and sped up. There wasn't room left to stop, especially with the rain. Since I was partially partially in the lane already and not side to side with him at this point, I kept driving. He decided to speed up and lay on his horn which is when he collided with my car, and I continued to drive into my car instead of braking. I think at this point I just tried to pull back over towards the right as he was fully pushing my car with no clear intention to brake. I don't know if he was debating whether or not to pull over but it took a while of me following him for him to finally stop. At which point I called 911.</p>
