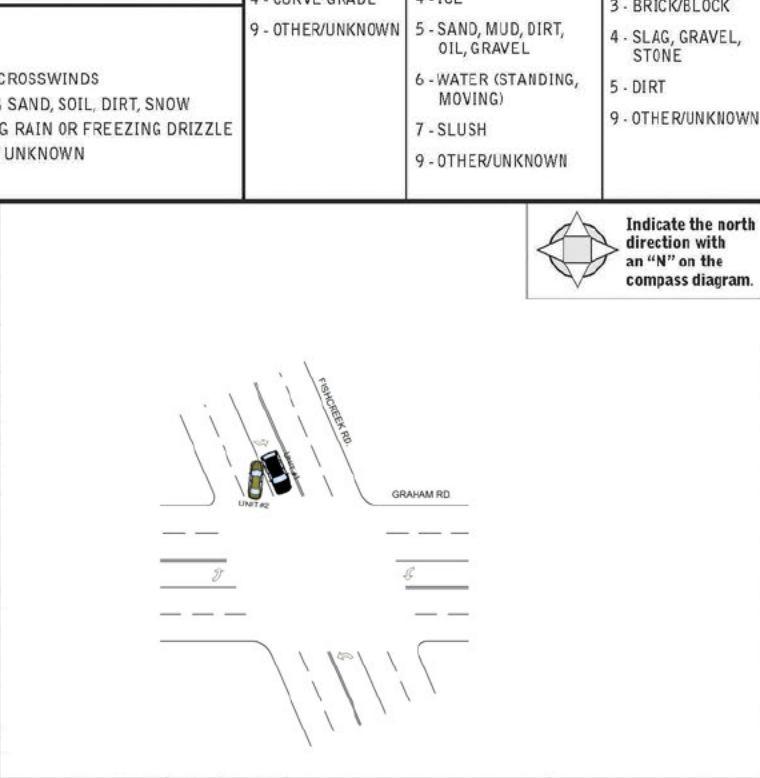

UNIT #1 WAS STOPPED IN THE LEFT-TURN LANE ON FISHCREEK RD. WAITING TO MAKE A LEFT-TURN TO HEAD EASTBOUND ON GRAHAM RD. UNIT #2 WAS IN THE LEFT-TURN LANE ON GRAHAM RD. ATTEMPTING TO MAKE A LEFT-TURN TO HEAD NORTHBOUND ONTO FISHCREEK RD. AS UNIT #2 MADE THE TURN, UNIT #2 WENT LEFT OF CENTER. AS A RESULT, THE FRONT PASSENGER SIDE OF UNIT #2 STRUCK THE REAR PASSENGER SIDE OF UNIT #1.

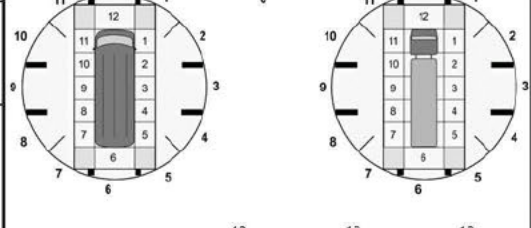

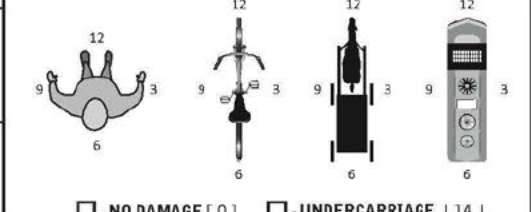
