Vehicle #1 was driving South on Darrow Lake Dr. Vehicle #1 made left turn into the shared driveway of residences 2098, 2090 and 2082 Darrow Lake Dr. Vehicle #2 was parked and unoccupied on the private driveway, with enough room for a passenger car to fit through. Vehicle #1 attempted to exit the private driveway through the south point. Vehicle #1 struck vehicle #2, damaging the hood mounted backing mirror. The driver of vehicle #1 stated he attempted to avoid striking the trash cans and inadvertently struck vehicle #2. No injuries were sustained and no signs of impairment were observed by either driver. Images added to digital media file.

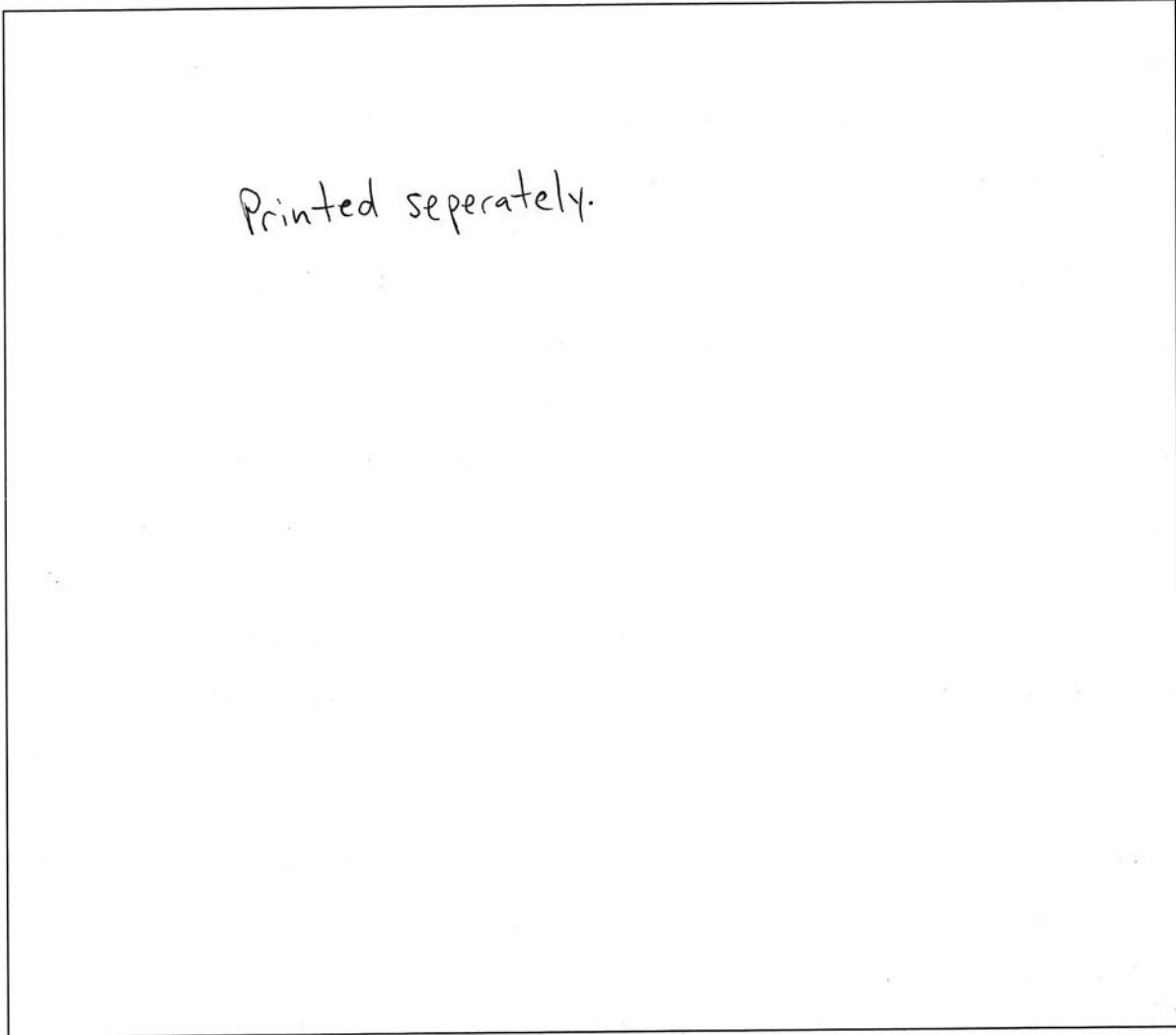

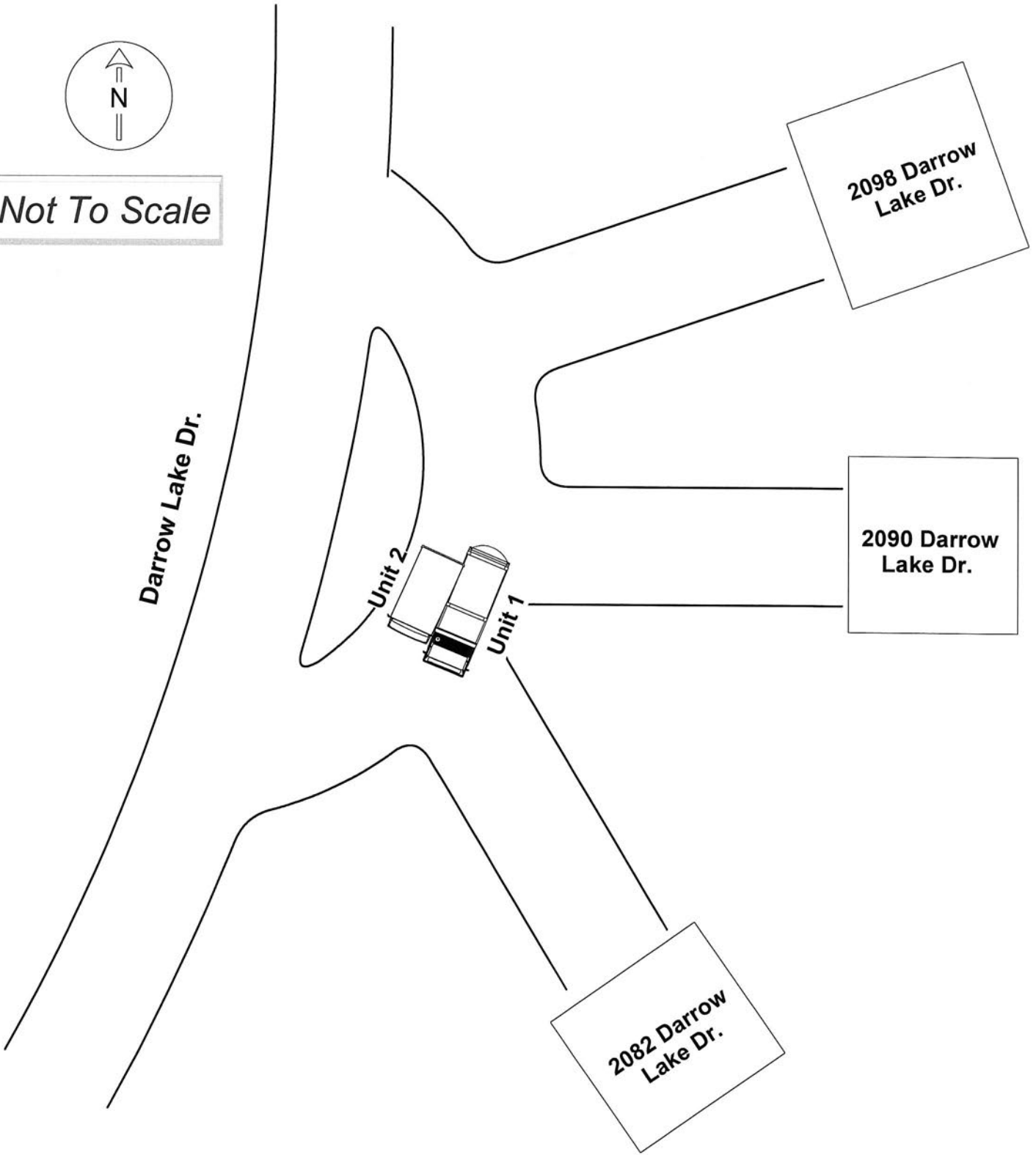
