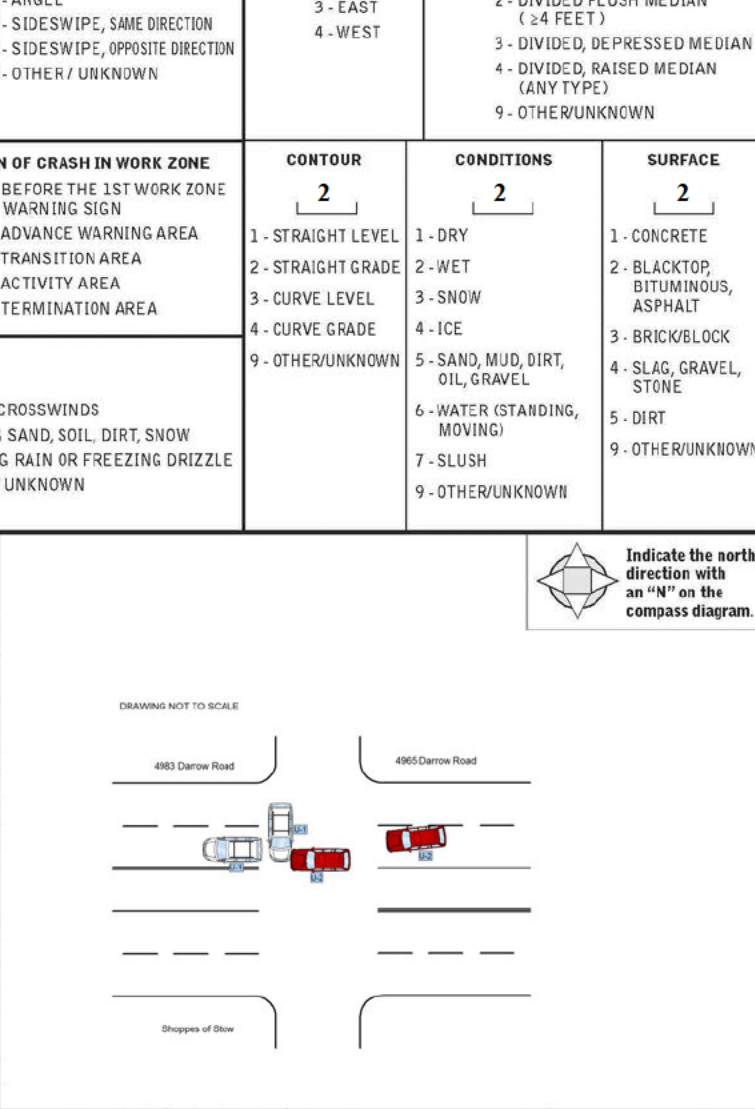

NARRATIVE  
**Unit-1 was exiting the drive between 4965 and 4983 Darrow Road west-bound to turn left onto Darrow road. Unit-2 was traveling north-bound on Darrow Road approaching unit-1's location. Unit-1 pulled into Darrow Road and according to unit-2 stopped in the right lane. Unit-2 states he switched into the left lane to continue when unit-2 then continued in front not assuring it was clear to exit the private drive onto the roadway and causing the crash. Unit-1 did not wish to write a statement but stated he was moving less than 1mph when he was struck.**
