UNIT-2 WAS OCCUPIED WITH THE LISTED DRIVER ALONG WITH HER TWO YEAR OLD AND TEN MONTH OLD DAUGHTERS. THERE WAS NO APPARENT DAMAGE OR INJURIES.

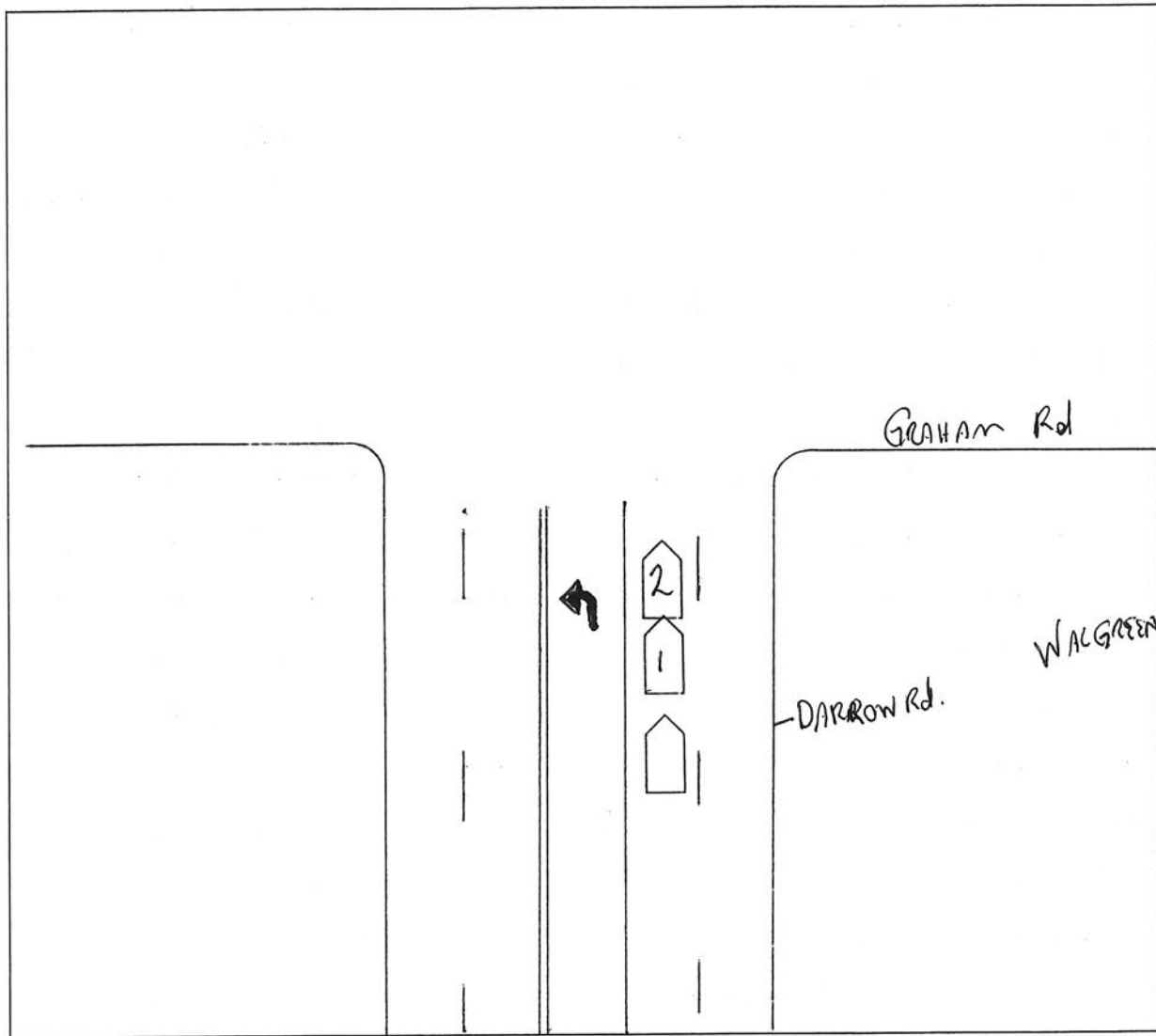
