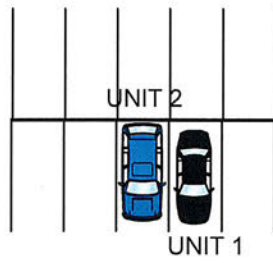
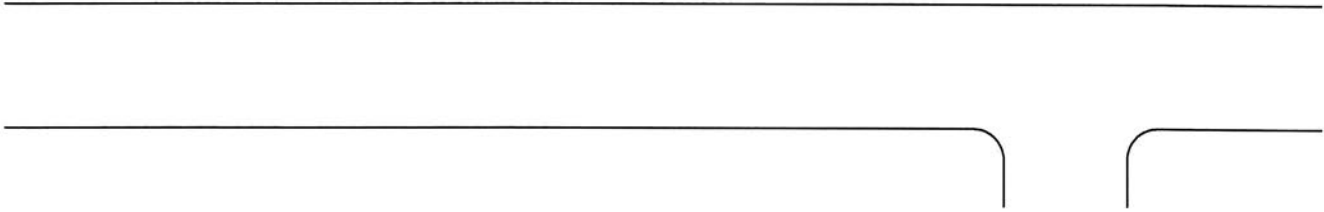
DESCRIBE WHAT HAPPENED

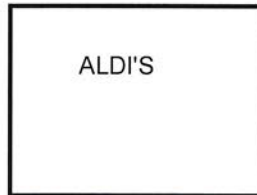
