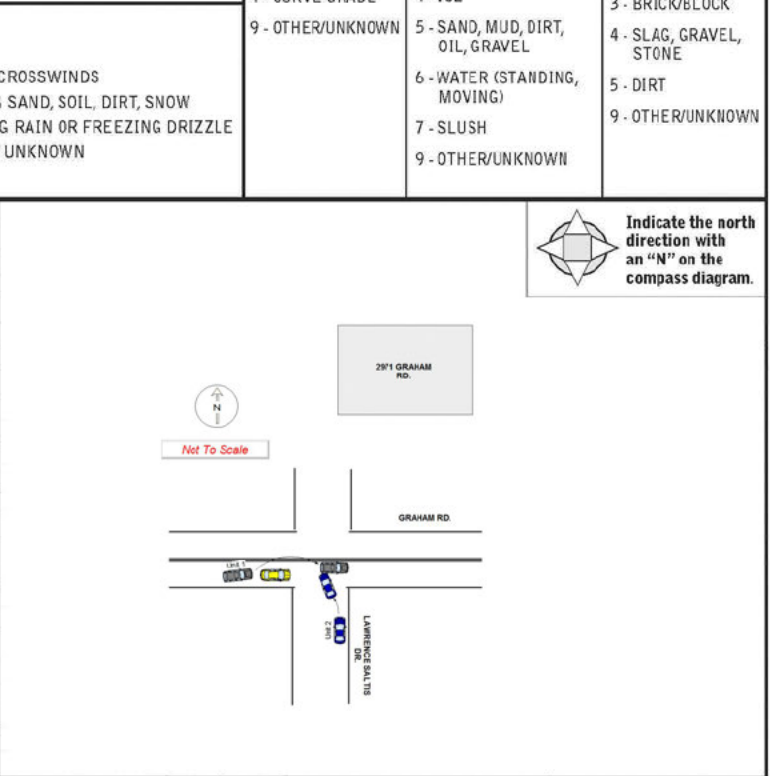

NARRATIVE

Unit 1 was traveling east on Graham Rd. and stopped at Lawrence Saltis Dr. where the vehicle ahead of them was stopped. Unit 2 was turning west onto Graham Rd. from Lawrence Saltis Dr. The vehicle in front of Unit 1 was allowing Unit 2 to exit. Unit 1 then passed to the left of the stopped vehicle, possibly crossing the center line, to continue traveling east on Graham Rd. Unit 2 struck the rear end of Unit 1 at an angle. Both Units gave conflicting statements.

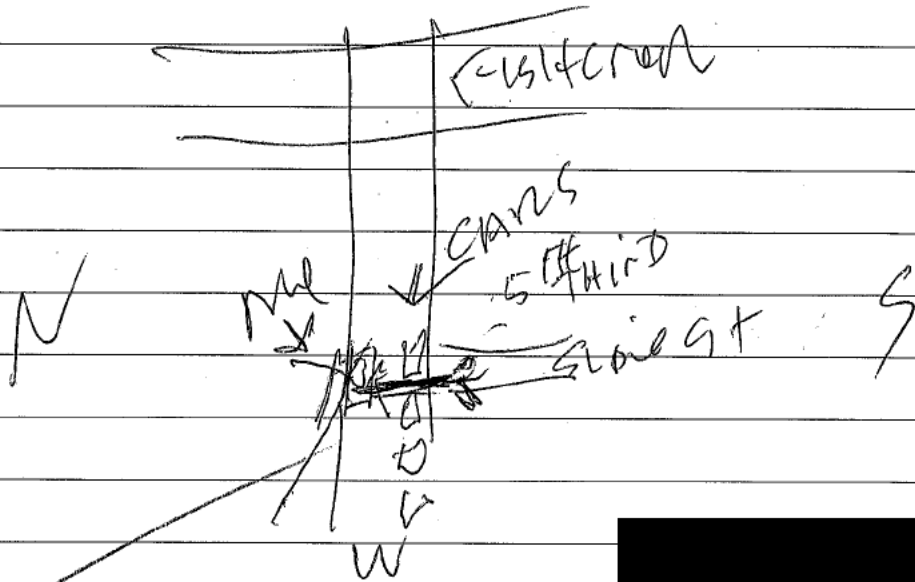




