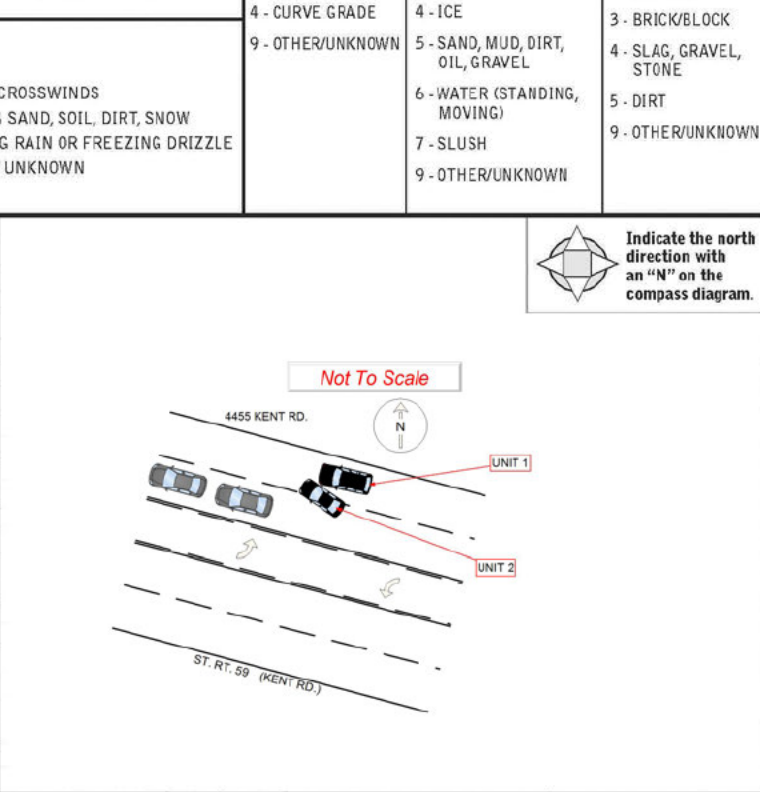

NARRATIVE

Unit 1 was in curb lane traveling west on St. Rt. 59 in front of 4455. Unit 2 was in the left lane traveling in same direction. Unit 2 driver stated that the vehicles in front of him began to brake. Unit 2 stated that he would not be able to brake in time to avoid collision and switched to the curb lane. Unit 2 struck Unit 1 in curb lane. BWC captured damage on vehicles. OH3s completed.
