DESCRIBE WHAT HAPPENED

Vehicle #2 turned right off of Norton Rd. and into the private driveway. Vehicle #1 was stopped on the private driveway at the traffic signal (Red) awaiting to turn left onto Norton Rd. Vehicle #2 made a left turn to pull into the Giant Eagle parking lot, and struck vehicle #1. Both the driver of vehicle #2 and an unbiased witness stated that vehicle #1 rolled back several feet from the traffic signal line, which caused vehicle #2 to strike vehicle #1. Statements are included in the case file. Images added to the digital media file. Driver of vehicle #1 denies his vehicle rolled backwards.

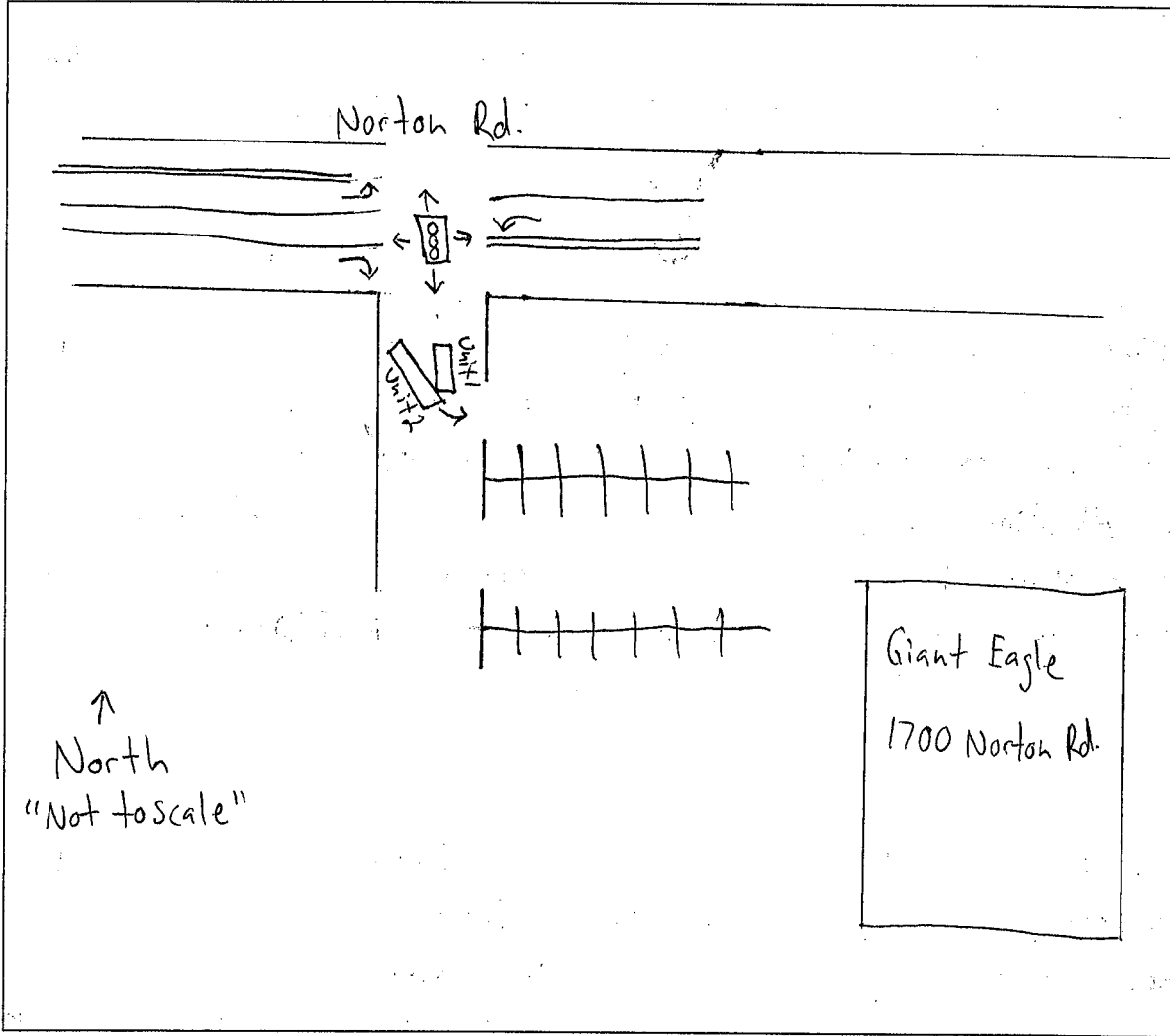


