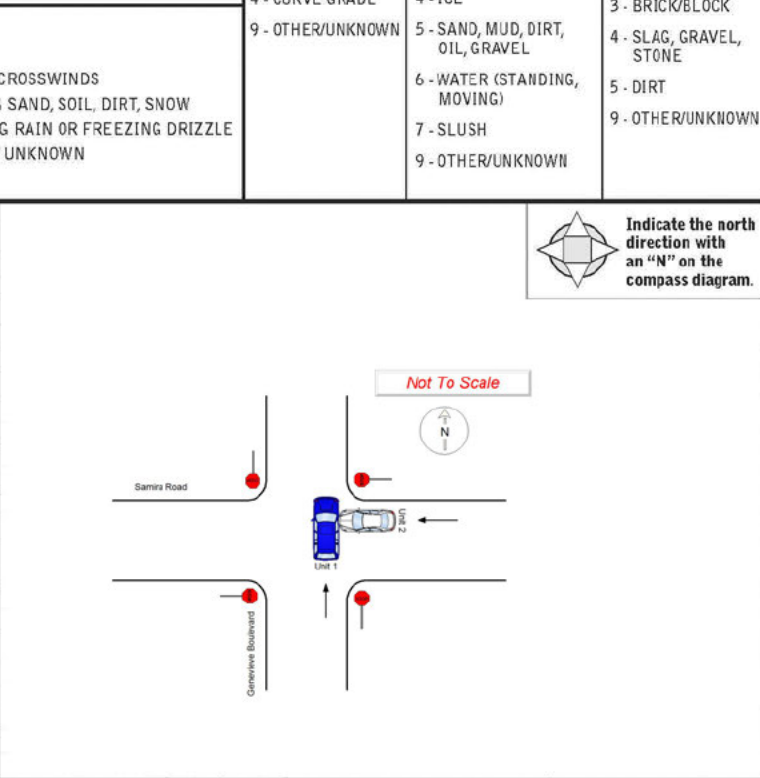

NARRATIVE

Unit #1 was northbound on Genevieve Boulevard and stopped at the stop sign at the intersection of Samira Road. Unit #2 was westbound on Samira Road and stopped at the stop sign at the intersection of Genevieve Boulevard. There are no witnesses as to who was at the stop sign first, or who failed to yield the right of way to the other unit. Both vehicles proceeded straight, and struck each other in the middle of the intersection.

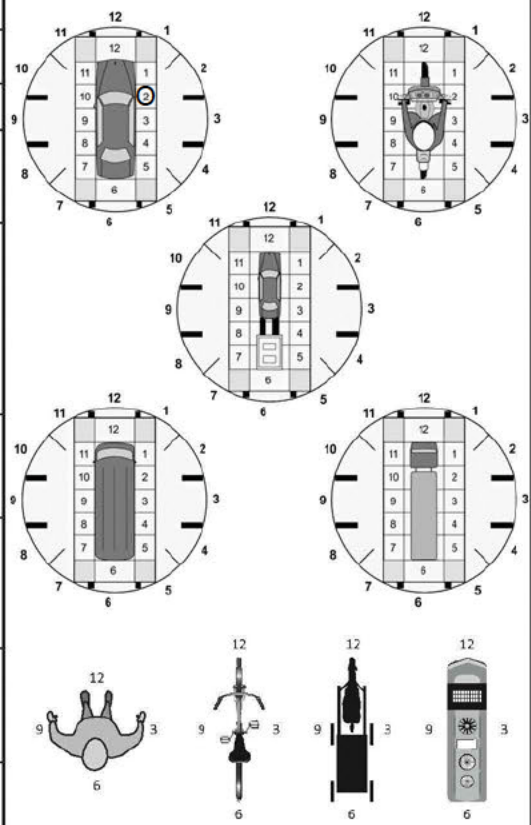

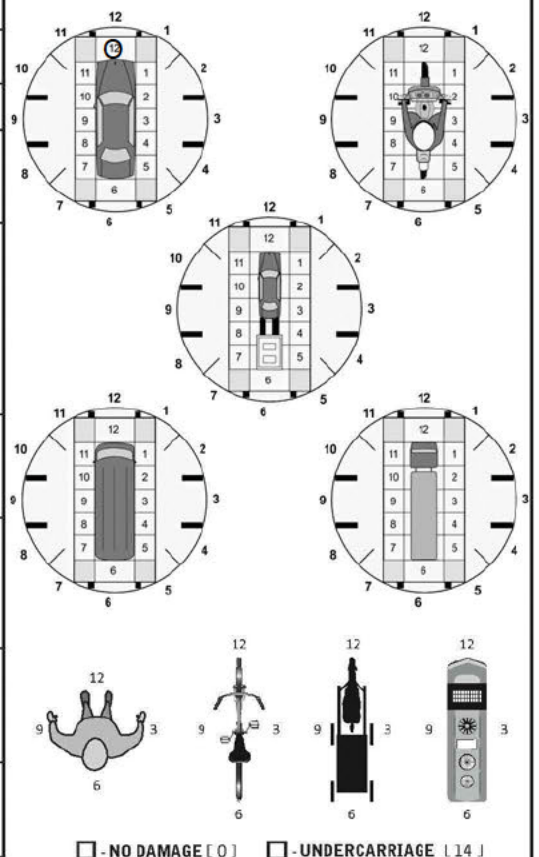
