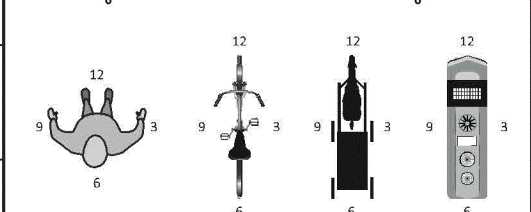

As I moved forward I noticed the black Lexus enter the intersection and I stopped and the Lexus impacted me. At the last minute before the impact I swerved to the left and this put me into the impact of the black Lexus. I was completely stopped when the black Lexus hit me. I had started to make the turn but stopped when I saw the black Lexus and then it impacted me.
