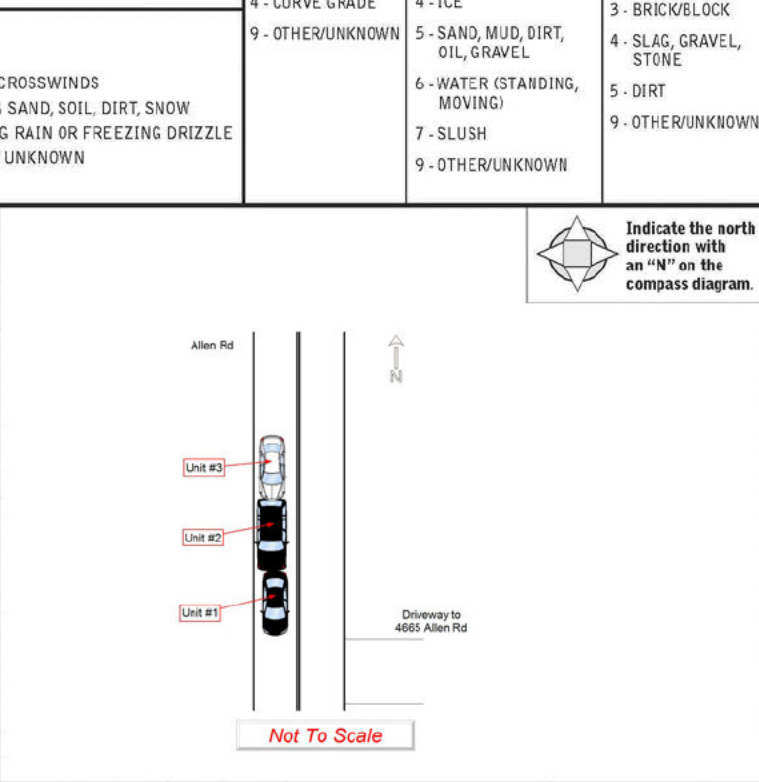

Unit #3 was traveling directly behind Unit #2 and failed to maintain assured clear distance ahead striking the rear of Unit #2. The impact forced Unit #2 into the rear of Unit #1.**

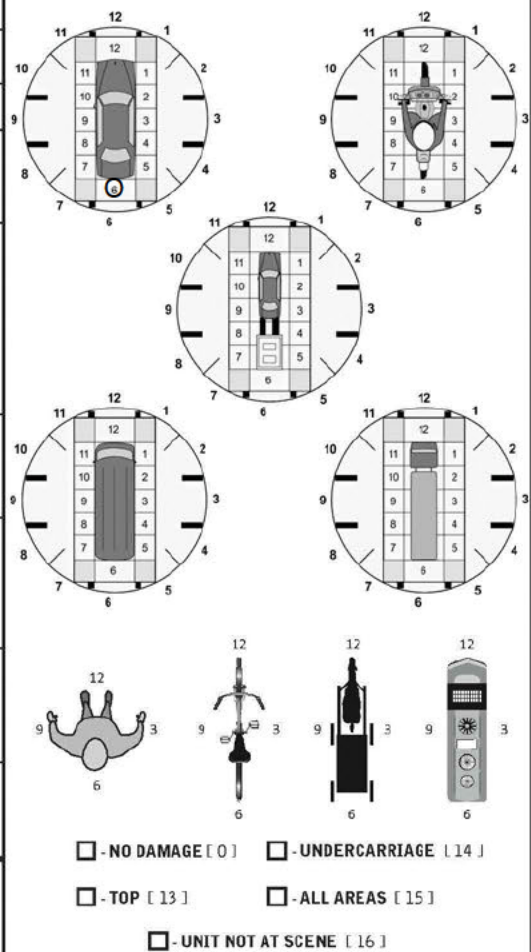

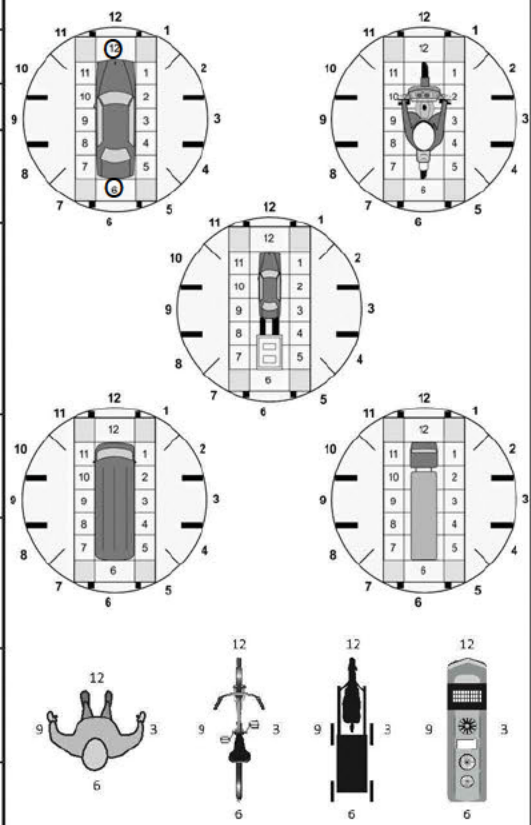
