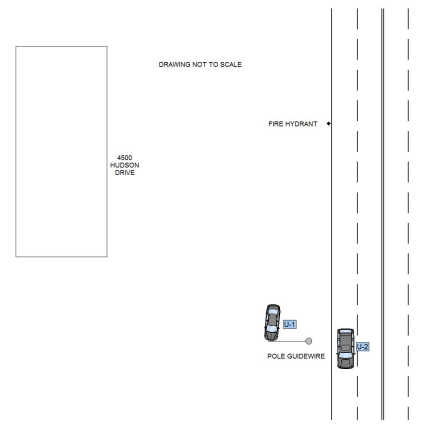
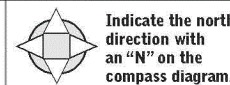

Unit 2 and witness both state unit 1 changed from the left lane to the right lane and clipped the rear of unit 2 while traveling s/b on Hudson Drive. Unit 1 then went off of the right-side of the road, jumped the curb, hit a fire hydrant and came to a rest against a telephone pole support guide wire. The driver of unit 1 stated he worked all night last night and after taking a nap in the parking lot thought he was okay to drive home. He states he fell asleep driving home and that was the last thing he remembered prior to the crash.
