


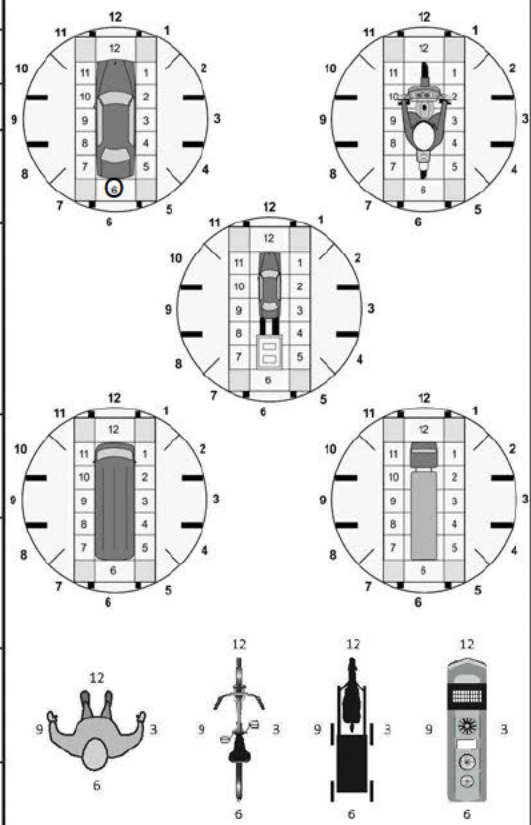

I was in the left lane and was at 35 miles and the vehicle in front of me suddenly turned its indicator to the left and stopped due to traffic and on back of it I was stopped I think like 10 to 15 seconds and in the next moment a car came from back end hit my vehicle I was still holding my brake so I didn't hit the front vehicle. and when I came to senses I just moved my car to roadside and called 911 immediately and informed the situation to them.

Due to the impact I had some neck and back pain.
