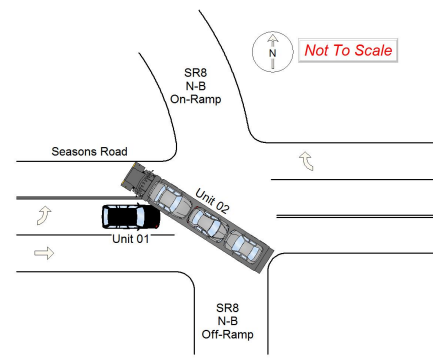
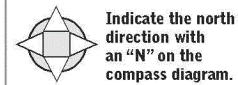

Unit #1 was east on Seasons Rd stopped for a traffic light, waiting to turn left to go n/b on SR 8. Unit #2 was north on SR 8 exiting at Seasons Rd to turn left and go west on Seasons Rd. Unit #2 turned improperly, taking the turn to close to eastbound traffic, and the trailer portion struck the front driver side of Unit #1.

The driver of Unit #1 was unable to back up as there was a car behind her. After seeing that the truck was not going to stop, she followed and called police. The car that was behind her at the light did not stay as a witness.

The truck left the area and the driver of Unit #1 got pictures of the violator then parked to await police. A Cuyahoga Falls officer made contact, advised the driver of Unit #1 that the crash occurred in Stow, and referred her to our agency.

I followed up on the hit skip report and eventually contacted Justin Fraser, the registered owner of trailer plate TRM4653 (Hudson Auto Transport, LLC). He explained that he sold that trailer to Central Noor of 4441 State Rd, Peninsula.

I advised the driver of Unit #1 via email: 1) I was able to locate the tractor trailer in a truck lot behind 4937 State Rd in Peninsula around 9 pm but there was nobody in it. 2) The trailer is registered to a previous owner and the current owner never transferred the plates or registered it with the BMV. 3) The current company owner is listed in the crash report. 4) I will submit the report tomorrow so it will be available by Wednesday.

I will try to find the driver and get insurance information, however; for your convenience I may just submit it as "unsolved" so that your insurance company can work on processing the claim and use their database to locate insurance information (they will need the information on the crash report). This does not mean I will be done though, as I will still try to find the driver and/or verify insurance information.
