Unit 1 was parked facing north at Target. Unit 2 pulled into the parking space to the west of unit 1, making a wide turn and striking Unit 1.

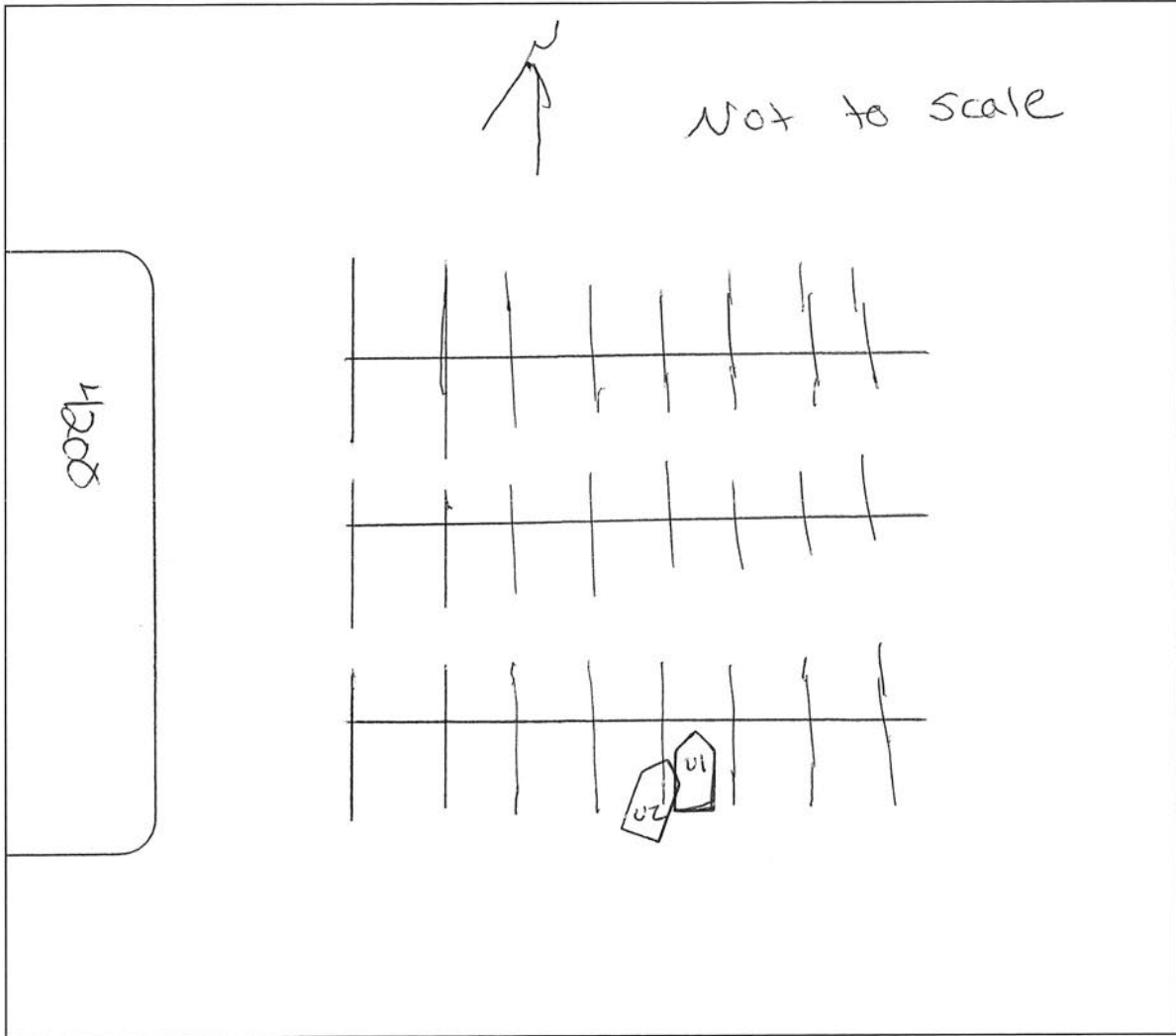
