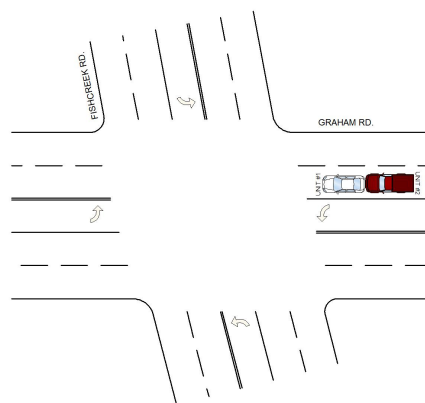
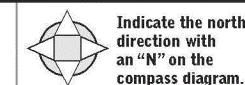

UNIT #1 WAS IN THE LEFT-STRAIGHT ONLY LANE TRAVELING WESTBOUND ON GRAHAM RD. APPROACHING THE FISHCREEK RD. INTERSECTION. UNIT #2 WAS DIRECTLY BEHIND UNIT #1. UNIT #1 CAME TO A COMPLETE STOP AT A RED LIGHT AT THE INTERSECTION. UNIT #2 WAS FOLLOWING TOO CLOSELY TO UNIT #1. AS A RESULT, THE FRONT END OF UNIT #2 STRUCK THE REAR END OF UNIT #1. THE DRIVER OF UNIT #2 WAS FOUND TO BE IMPAIRED AND WAS
