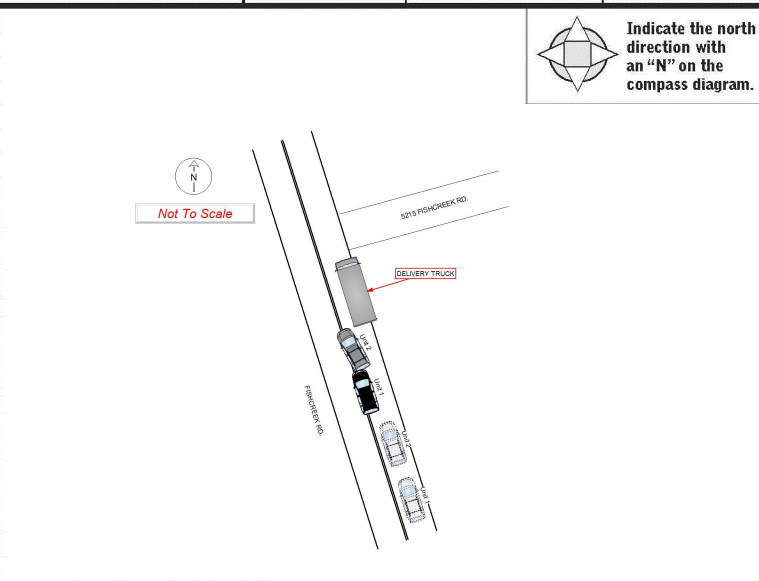

Both units were northbound on Fishcreek Rd. Unit #2 was in front of unit #1. There was a delivery truck at 5215 Fishcreek Rd. which was partially blocking the northbound lane. Both units began to go left of center to get around the obstructing truck. Both units came to a stop due to oncoming southbound traffic. Unit #2 then made an improper backing movement and struck unit #1. OH-3 statements were declined.

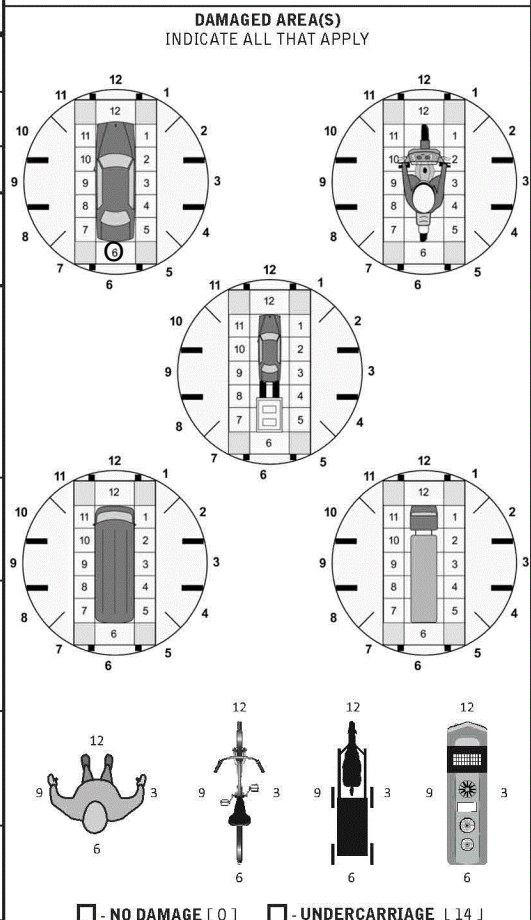

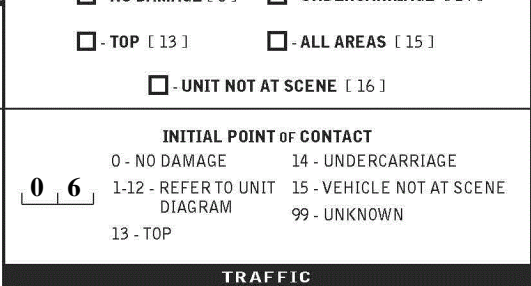
