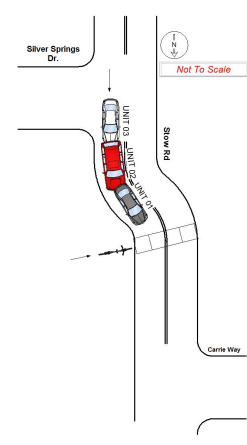

NARRATIVE

Unit 01 was traveling northbound on Stow Road, between Silver Springs Dr and Carrie Way near the Bike and Hike Trail. Unit 01 stopped for a bicyclist that was approaching the crosswalk for the intersection of the trail and Stow Road. Unit 02 was traveling directly behind Unit 01 and stopped. Unit 03 was directly behind Unit 02. Unit 03 failed to maintain assured clear distance ahead and struck Unit 02, causing Unit 02 to strike Unit 01.

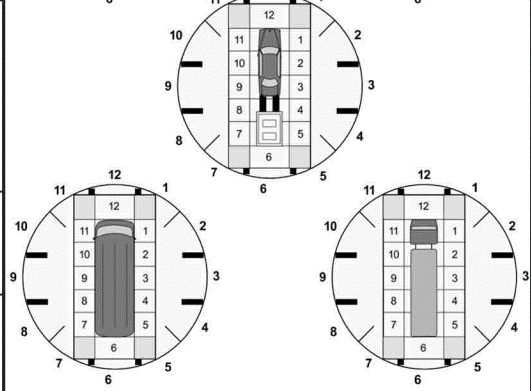

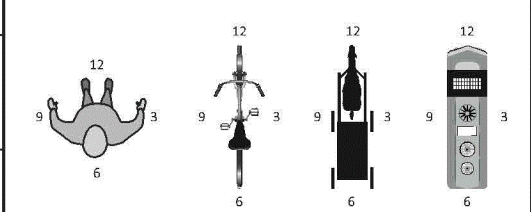
