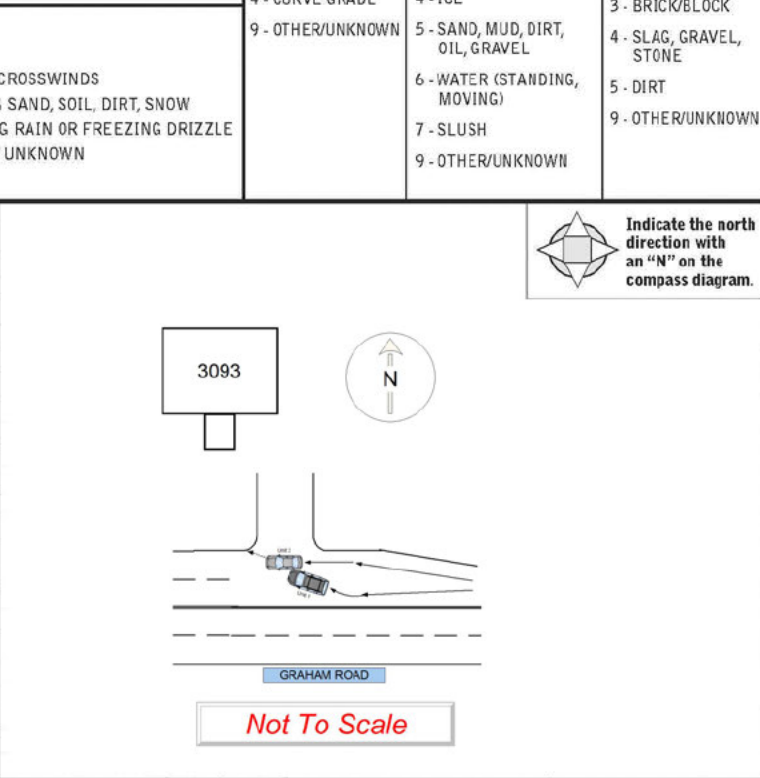

NARRATIVE

UNIT 1 WAS TRAVELING WESTBOUND IN FRONT OF 3093 GRAHAM ROAD AND PREPARING TO MAKE A RIGHT TURN INTO THE PARKING LOT OF THAT ADDRESS. UNIT 2 WAS ALSO TRAVELING WESTBOUND ON GRAHAM ROAD AND WAS PASSING UNIT 1 ON THE RIGHT. UNIT 1 STRUCK THE REAR DRIVER'S SIDE OF UNIT 2. UNIT 2 THEN STRUCK THE CURB WITH ITS FRONT PASSENGER SIDE TIRE CAUSING DISABLING DAMAGE.

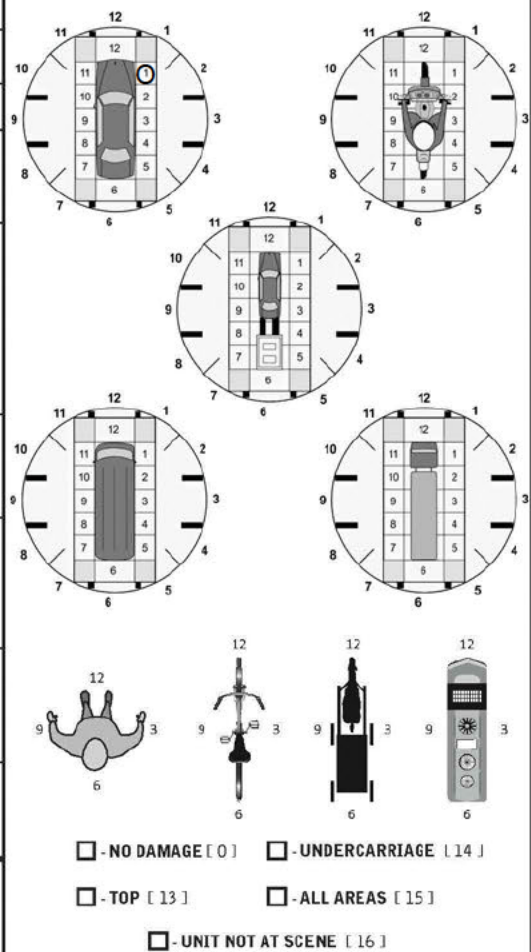
