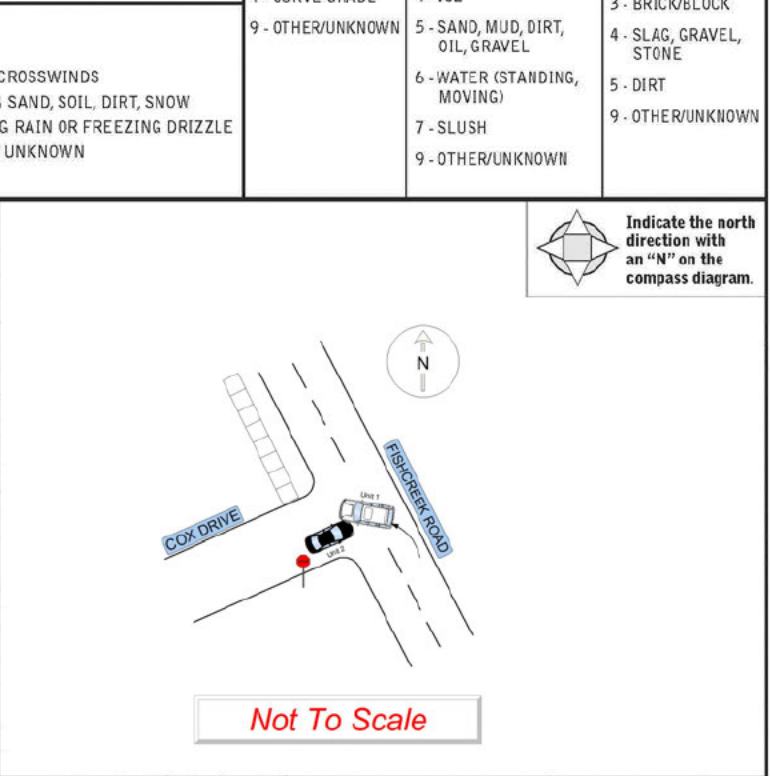

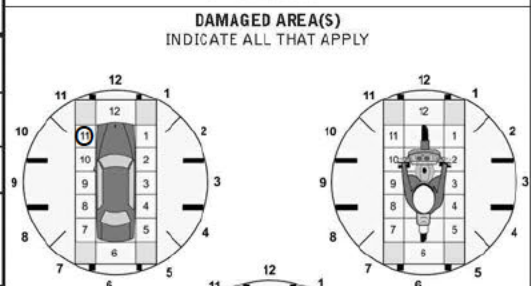

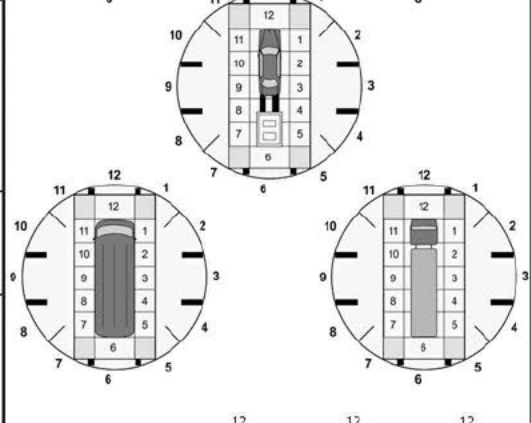
# OF TRAILING UNITS

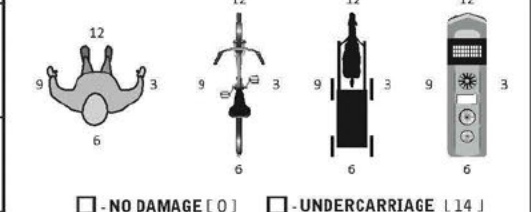

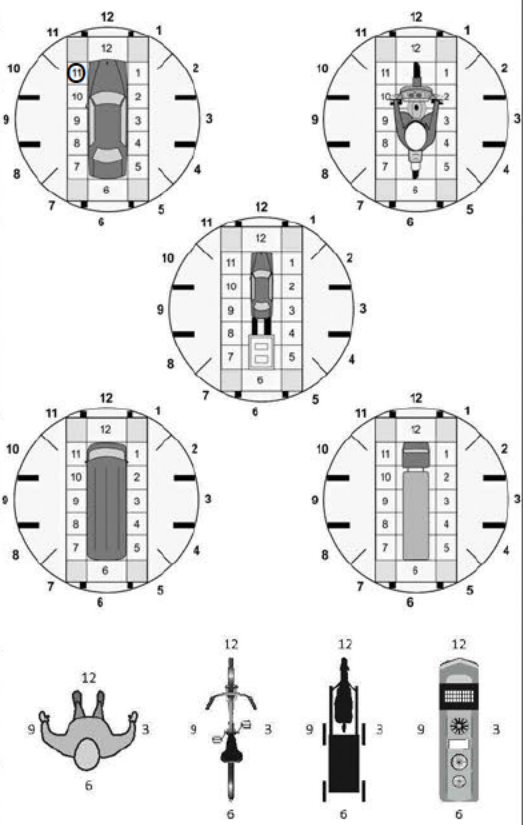
