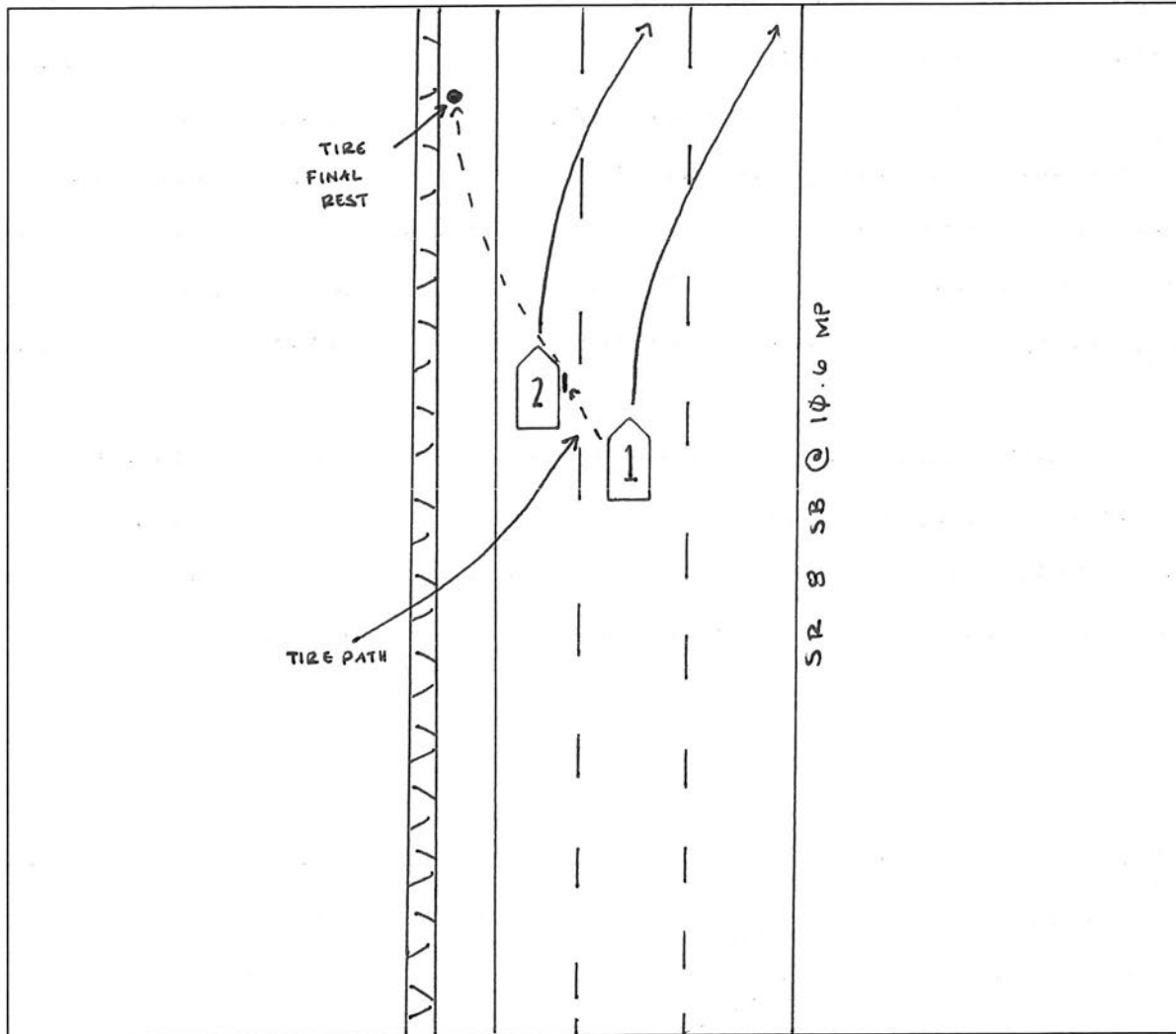




April 16th @ 8:00PM Heading South on Rt #8 near "on Ramp at Seasons Rd." A ~~Grey~~ Car Passing me on my right, while I was in the middle lane. The drivers left Front tire began to wobble. I moved left to the far left lane just as the tire flew off heading toward me. I heard the tire and wheel hit my car on the right side. I was traveling at @ 60mph the car was going @ 5-10mph faster. The tire & Assembly put some scratches on the Right Rear Door area & rear quarter Panel on the Passenger Side. I pulled off the road as soon as possible about 1/4 mile down the road. and called Police to report incident.
