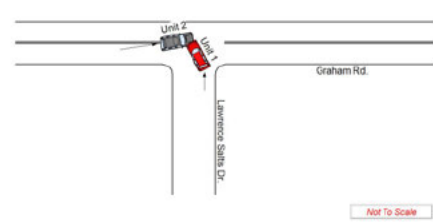
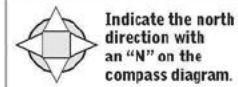

NARRATIVE

Unit 1 was stopped on Lawrence Saltis Dr. at Graham Rd. attempting to make a left turn to travel west on Graham Rd. Unit 2 was traveling east on Graham Rd. approaching the intersection of Graham Rd. and Lawrence Saltis Dr. The occupants of Unit 1 state that vehicles in the eastbound lane on Graham Rd. had stopped to allow Unit 1 to make the left turn. After Unit 1 began the left turn, Unit 2 passed the stopped vehicles, crossing the double yellow line, and struck Unit 1. The driver of Unit 1 states there were no vehicles in front of his, and reported Unit 2 failed to yield to the right of way when making a left turn. There

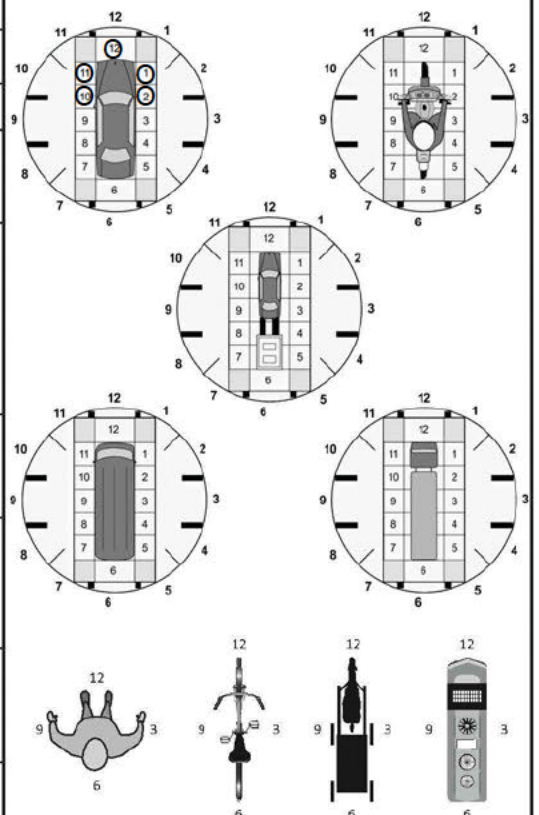
