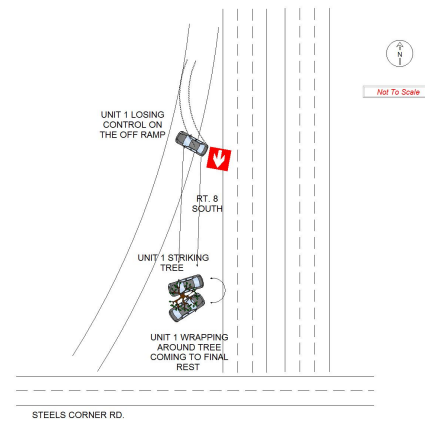

NARRATIVE
Unit 1 was traveling South on Rt. 8 South near Seasons Rd.
The vehicle was clocked by Lidar traveling at 100 mph. A traffic stop was initiated which the vehicle fled, turning off their headlights and continuing speed. Unit 1 lost control near Steels Corners Rd. on the exit ramp, striking a tree in the embankment. The driver is suspected to have major injuries while the two passengers had minor injuries.
One of the passengers was transported to Akron General Hospital and the driver was transported to Akron City Hospital.

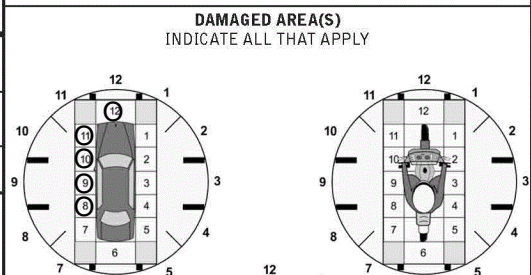

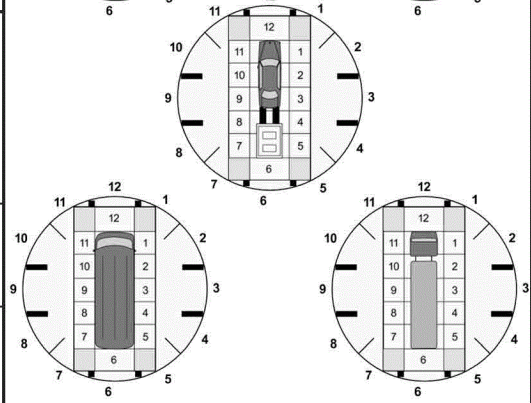

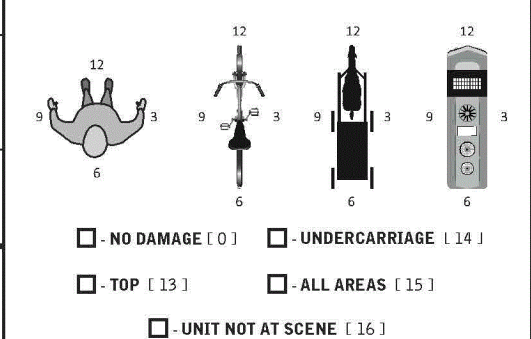
