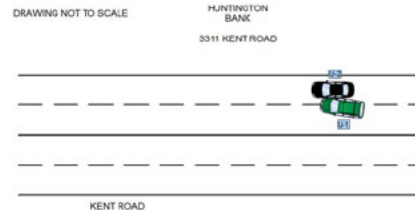
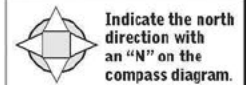

**Unit-1 was in the left lane and unit-2 was in the right lane. Unit-1 states he attempted to switch lanes into the right lane to then turn right into Huntington Bank but failed to see unit-2. Unit-1 struck unit-2 after not properly maintaining his lane until it was clear to make a lane change.**

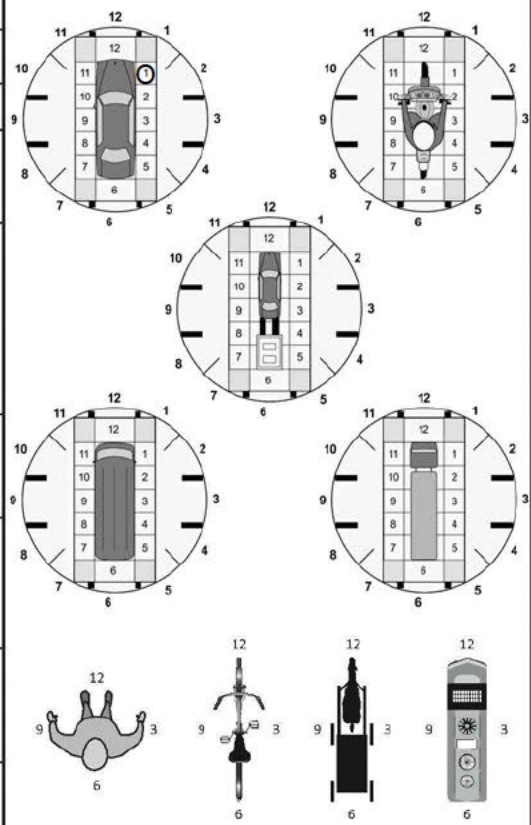
