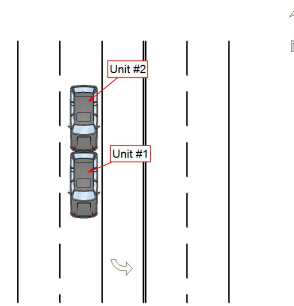
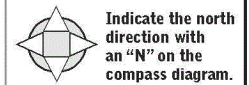
ROADWAY DIVIDED

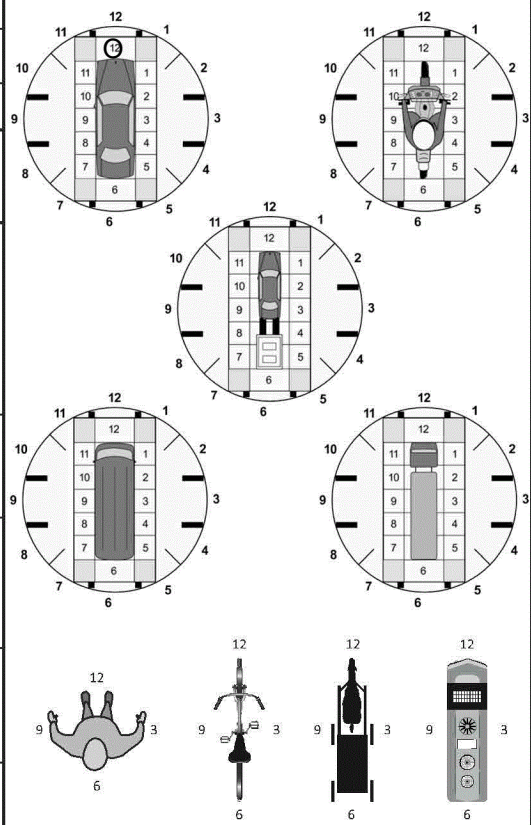
